
The Barn - First Floor





On 4 July 2015 you convened a meeting at Yarnton Manor to discuss your application for a new premises licence.

You indicated that Minutes of the Meeting would be made available but to date this has not been done.

As you know about a hundred Yarnton residents attended the Meeting and their principal concerns were expressed by numerous speakers.

These concerns in essence were that whilst Yarnton Manor had given information as regards its summer school run by Oxford Royale and some information about a few events that it intended to run at Yarnton Manor under the auspices of its events company Winterwell Ltd, the simple vital fact was that the widest possible terms of licence had been applied for.

Amongst other questions, you both and the rest of your team were repeatedly asked to clarify precisely:

- 1. How many such events were envisaged?
- 2. How many people were expected to attend?
- 3. How many cars and/ or buses were expected to attend?
- 4. What sound levels were going to be used for the live and amplified music?

However you were unable or simply unwilling to give answers to these questions which understandably only increased the concerns of the villagers.

These concerns were not allayed by the open letter dated 4 July 2015 from Yarnton Manor Estate that was given to everyone as they left the Meeting because whilst some more information was provided and in particular as regards the planned Winterwell Festival on 29 August 2015, we were still left in the dark as regards the *other* events planned to take place at Yarnton Manor with the above-mentioned key questions still remaining unanswered.

At the conclusion of the meeting I approached you both and other members of your team and introduced myself as being a person who was working with a number of other Yarnton residents.

I explained that we represented a significant number of Yarnton villagers who were loosely affiliated as The Beautiful Yarnton Residents Group all of whom were most concerned by the vagueness of your actual plans for events at Yarnton Manor which would require to be licensed in light of the widest possible scope of the new Premises Licence for which you had applied.

In an effort to avoid unnecessary dispute over this I and others in our team offered to enter a dialogue with you to see if we could resolve conditions for your Licence by agreement before the Hearing on 28 July 2015.

I invited you to correspond with me and you gave me to understand that you would consider this invitation to dialogue and respond.

To date we have not had any such response and accordingly are left to conclude that you do not wish to enter any direct dialogue with the Beautiful Yarnton Residents Group.

Dear Residents

We are offering this meeting today as an opportunity for concerns to be raised, and these addressed, in relation to the Estate's premises licence application listed for hearing by the Licensing Sub-Committee of the Council on 28 July and in relation to the Winterwell event on 29 August 2015.

We appreciate that this meeting was arranged at short notice. However today was chosen because, as you may know, the hearing date for our premises licence of 28th July has only recently been scheduled by the Licensing Sub-Committee, and to get this session in a reasonable time ahead of that date we have had to fix a date early in July. Logistically the date had to be 4th July, because the Manor (otherwise full of students) is empty for a changeover day with one group of students having left this morning and another group not arriving till tomorrow morning.

Premises Licence Application

We have received a number of enquiries about our recent application for a premises licence to show films, play recorded and live music (to the extent now required) and (where appropriate) serve refreshments and alcoholic beverages (all regulated activities) at the various functions that will take place at the Manor over a normal year. The question has been asked: What are our intentions in this, and what might be the impact of what's proposed on the surrounding community if granted?

We must stress that we are primarily applying for administrative reasons. A single licence for regulated activities is valid for a year, and thereafter is subject to an annual fee. Having a single annual licence in place saves our having to make an application to the Council by temporary event notice (TEN) each and every time a function is to take place during the year (but see below as to the maximum permissible of these).

We have already applied for and been granted TENs for the 6 presently-anticipated number of events and functions associated with our student summer courses. These are non-alcoholic functions usually associated with the ending of a course for a batch of students e.g. a graduation disco. 2 of these have taken place already on 19th June & 3rd July without a problem.

But we need to be flexible, as we are setting up here an all-year-round educational centre, and groups of students may be having graduation discos or similar, or functions may be arranged for them, all through the year, or scheduled dates may need to be changed.

To date the maximum number of TENs that might be applied for in a year is 12. Parliament has now increased this to 15 in any calendar year. Beyond that number, a single annual premises licence is required.

Functions to be held are not only student-related events. The Manor has for a long time been pleased to make its facilities available to couples for weddings, for example, averaging a small number of these during the year. Residential conferences may also be held, to which functions attach and there may be other functions or events – for example a few years ago the Manor hosted the St Hugh's College Annual Ball.

Without a premises licence, we would be unable to carry on our business of this kind beyond the maximum permissible number of TENs during a year. All who have visited our fine Grade 2* Listed Jacobean building will have no difficulty imagining the cost of maintaining its fabric in a state that can be enjoyed by future generations. As in every other sphere of public life, we need to be able to make good use of our asset, provided our activities are run in a way that is appropriate and sensitive to the interests and amenity of our neighbours.

Another need for the premises licence is in relation to the showing of films for educational (and commercial) purposes. At present we have a licence in place for the copyright aspect of showing films, but we don't have a licence for the actual showing of films (e.g. as a part of our educational courses – again, to the extent that this is required by law).

Separately, we had thought that the showing of films (such as vintage movies) on a giant inflatable screen might be something the village might find attractive down the line. We would not be intending to do this regularly, perhaps once or twice a summer, but currently permission for this would need to come out of our annual TEN allocation.

We have closely followed the guidance given by Cherwell District Council in their application documentation by:

Posting up a copy of our application on the gate outside the Manor on the blue A4 paper supplied by the Council. This notice has been in effect since 6 June.

Submitting a copy of the application to the Oxford Mail for publication for Yarnton residents and people further afield to see.

Publishing the application in the Oxford Mail online for web-viewers to see.

Copies of published notice and the application are attached. Their prescribed format does not allow for much explanation to be included. The prescribed notice is just a bare, factual statement of the types of regulated activities and the hours applied for. So just reading it on its own may give cause for concern. This is perhaps particularly so in relation to the hours and days applied for. To explain, though:

We may want to be showing <u>films</u> (mostly to students) <u>indoors</u> on any day of the week, so permission for this 5.00 pm to 2.00 am Monday to Sunday has been applied for.

Outdoors (practically speaking in the rear gardens of the Manor) permission applied for to show films has been restricted to 5.00 pm to 11.00 pm Monday to Sunday.

Permission to play <u>Recorded music</u> (e.g. music played from CD) <u>indoors</u> has been applied for (very often at functions for students, other residents & guests) on Thursdays to Sundays 1.00 pm to 3.00 am.

Outdoors, the permission for recorded music has been restricted to between 1.00 pm and midnight Thursdays to Sundays inclusive.

The playing of <u>live music</u> (any kind of live music from a concert pianist to a dance band) is a different regulated activity. Permission for this has been applied for <u>indoors</u> between 1.00 pm and 3.00 am Thursdays to Sundays.

Outdoors (which means in practical terms in the rear gardens of the Manor) permission to play live music has been applied for between 1.00 pm and midnight Thursdays to Sundays.

Associated with the above activities indoors or outdoors, permission to supply late-night refreshments has been applied for Thursday to Sunday 11.00 pm to 3.00am.

Again, associated with the above activities indoors or outdoors, permission to sell alcoholic drinks (e.g a cash bar for departing residential conference attendees) has been applied for Thursday to Saturday 1,00 pm to 3.00 am, with Sunday those hours restricted to 1.00 pm to midnight.

None of this means that we have the intention of showing films, playing music, selling refreshments and selling alcohol on every one of those permitted days during all those permitted hours. These days and hours applied for are an overall permission for regulated activities on occasions to be authorised by the required licence.

The guidance that we received from the Council is to apply for days & hours which are sufficient to include regulated activities at all types of anticipated functions or events, so as not to need to re-apply for variations of the licence terms every time a function is booked which might need regulated activities to be running outside the shorter hours originally applied for. So, for example, it's very unlikely that we would be running a film show for young students till after midnight, and no alcohol would be supplied to them in any event, but if one of the Oxford Colleges (as St Hugh's have done in the past) were to want us to host their May Ball, or a wedding or birthday party hosted at the Manor were to want their reception to go late on a light mid-summer night, then that 3.00 am longstop time might be needed.

Essentially, these are longstop hours sufficient to cater for all the different types of function that we envisage we might need during the year.

Winterwell

One of these functions is the hosting of the one-off, one-day Winterwell event on 29th August, when the Manor will be closed to students, run by our events-operating company Winterwell World

We have already been granted permission for this under a TEN that we submitted. A copy of that grant and the application for it (with confidential details redacted) is attached.

Winterwell is in essence a summer garden party, with music going on into the night, for likely about 350 to maximum 499 people, with associated supply of refreshments, alcohol, and possibly showing of films. Winterwell has been in operation for almost a decade at various venues (including in Oxfordshire) without incident and is run by a team of experienced event management professionals.

In practice an event of this nature is not unlike a large private party, or a wedding, or a function such as a College Ball.

The size of the event will be easily accommodated within the 7-acres of the Manor gardens. We will ensure appropriate security measures and infrastructure are in place to allow the event to run smoothly and without incident. Staff and security measures will be in place to ensure that guests are kept to the designated areas for the event and not allowed to roam around the agricultural fields belonging to the Estate.

We are aware that the outdoor music will be audible to some local residents, and will be taking steps to limit as far as reasonably practicable any disturbance that this may cause. The music will be contained to the back lawns of the Manor, which are surrounded by walls and high trees. The playing of outdoor music will be over by 9.00 pm. After then music will be played indoors.

In relation to traffic and access for the event, we do not think there is likely to be material impact on Church Lane. However, we will be taking advice from an independent traffic consultant on this point at the appropriate time.

Winterwell is open to anyone (subject to security and to numbers) and features garden games, lawn tennis, croquet, picnics, live music and much more. A discount is available for Yarnton residents and anyone interested should enquire via the Winterwell website at www.winterwell.co.uk. Two very worthy charities - War Child and Care International - are being supported this year, and we hope to raise as much money for them as possible.

General

Primarily, we are an educational company, first and foremost working with the interests of our staff and students in mind. However, as previously indicated, running ancillary events (e.g. during the holiday or low-season) is absolutely fundamental to our business, as it provides needed income to go towards maintaining the Estate throughout the year. This is not uncommon in the Oxford University Colleges, all of which generate extra income when their students aren't on site to contribute towards, for example, increasingly expensive building repairs.

Hopefully the above explanations will alleviate concerns and correct a certain degree of misunderstanding as to what is intended by the premises licence that we have applied for, but this is an open information session and questions are welcome to be asked, through the meeting Chairman, of our representatives present.

We sincerely hope that this can be the beginning of a sustained dialogue between the Estate and its neighbours. Certainly this is our intention.



Transport and Access Appraisal - Cherwell Premises Application

1 Introduction

Subject

Technical Note

- 1.1 This Transport and Access Appraisal report is based upon instructions from Mr Michael Williams of Kings Retreat, Church Lane, Yarnton in Oxfordshire to review the premises licence applied for at Yarnton Manor, Church Lane, Yarnton to Cherwell District Council from a highways perspective.
- 1.2 A site visit has been carried out to appraise the above in terms of vehicle access. As part of this assessment the characteristics and design of the existing highway network has been considered alongside the appropriate design standards in Manual for Street 1 and 2 (MfS), to assess if the location of the proposed licensed events (ref 15/PRM0186/LAPRE1) via Church Lane is appropriate or not.
- 1.3 The proposed licensed events are summarised in the table below:



Technical Note

2 Site Location

2.1 Yarnton Manor is located within the southern part of the village of Yarnton, which is 1.6km (1 mile) southwest of Kidlington and 6.4km (4 miles) northwest of the City of Oxford. The 2011 Census recorded the parish's population as 2,545.



- 2.2 The village has a range of local amenities, which include a church, a village hall, a primary school (William Fletcher Primary School) and two public houses, the Red Lion on Cassington Road and the Turnpike on the A44 Woodstock Road.
- 2.3 Yarnton is served by a frequent bus service (S3) between Oxford and Woodstock, continuing on to either Charlbury or Chipping Norton. Most of the regular daily buses go to the rail station. There is a half-hourly service during the day with a limited service on weekday evenings and Sundays. There is a circular service linking Begbroke, Yarton and Kidlington. The majority of the buses go through the centre of the village, stopping in Rutten Lane and Cassington Road.

3 Existing Local Highway Network

3.1 Church Lane is designed as a typical rural lane and is classed as an unclassified road. Church Lane runs from its junction with Cassignton Road, past Park Close to the entrance of Mead Farm where it terminates (no through road).





- 3.2 The speed limit of Church Lane is 30mph with street lighting.
- 3.3 Measurements on site were undertaken at the Church Lane / Cassington Road junction in accordance with MfS due to the 30mph speed limit. The measurements on site confirmed that the appropriate sightlines of 2.4m x 43m (the 'X' and 'Y' distances) are not achieved (only 2.4m x 27m is available) when looking to the left towards Rutten Lane. The required 2.4m x 43m vision splay to the right is easily achieved i.e. measurements on site of 2.4m x 100+m achieved.

- 3.4 The carriageway width of Church Lane at 9.5m back from the Cassignton Road junction is 5.6m. This width then significantly reduces down to 3.8m a further 10m down Church Lane. There is a partial section of footway on one side of Church Lane that runs for 25.4m from the junction of Church Lane / Cassington Road, which then terminates. The width of this footway is measured at 1.2m. The footway then begins again some 38m later along Church Road for a short distance, until it ends again and begins on the opposite side of Church Lane up to the Church, where it terminates again.
- 3.5 As stated above Park Close is served by Church Lane and is located 67.5m down Church Lane from the Church Lane / Cassington Road junction. Park Close serves approximately 20 existing residential dwellings, most of which are retirement homes. Visibility sightline measurements were undertaken at the junction of Park Close and Church Lane at an 'X' distance of 2.4m. The visibility available to the left, when looking towards the Church Lane / Cassington Road junction meets the appropriate requirement of 43m. However, the vision splay to the right looking towards Yarnton Manor is obstructed by overgrown vegetation and is restricted to only 22m, which does not meet the design guidance in MfS.

- 3.6 Further carriageway measurements were taken along the remaining length of Church Lane from Park Close. These measurements varied in width from 2.9m to 3.2m up to the entrance of Yamton Manor where Church Lane was measured at its widest at 4.5m. It was observed on site that there is a single passing bay provided for cars along Church Lane, approximately half way down the road.
- 3.7 Within close proximity to the entrance of Yarnton Manor there is evidence of informal parking taking place associated with the Church and leisure walking due to the number of public rights of way in the area. The width of the entrance into Yarnton Manor (gate post to gate post) is 3.7m. The surfaced area in front of the entrance, which is used as a bell mouth to the site, is approximately 20m in length.




3.8 Church Lane does not terminate at the entrance of Yarnton Manor, this rural lane continues past the manor house for a further 164m. The width of this section of Church Lane varies in width from 3.2m to 3.6m up to the entrance of Mead Farm where Church Lane ends. It was noted at the end of Church Lane there is no turning head to enable vehicles to turn and travel back down the lane in a forward gear.

Technical Note

- 3.9 An informal enquiry for the highway boundary along Church Lane has confirmed that the highway boundary varies along the road. The boundary is either to the back-edge of the footway or verge along Church Lane for the majority of its length.
- 3.10 The public highway boundary within the vicinity of the main entrance to Yamton Manor is considered to be to the back edges of the carriageway including any verge or footway i.e. the surfaced area in front of the Manor's entrance is a mixture of private and public highway land.
- 3.11 There are a number of public rights of way (footpaths) within the area. Three of these are located within close proximity to Yarnton Manor, Numbers 420/5, 420/7 and 420/21.

4 Suitability of Church Lane

4.1 The premises licence being sought at Yarnton Manor for Film Exhibitions, Weddings and Music Festivals etc is expected to generate a significant number of traffic movements along Church Lane for each event, which will vary in size and weight. It is currently unknown what type of vehicle and how many will be attracted to the events planned, which is a concern in highway safety and capacity grounds.

From experiences with other events the vehicle types generally expected are (images below sourced from MfS):



Heavy Goods Vehicles (HGVs) or Lorries, Van/Mini Bus and Cars




Figure 6.18 Private and commercial motor-vehicles - typical dimensions.




Figure 6.16 Typical bus dimensions

4.2 The width of Church Lane (described in Chapter 3) for the majority of its length is too narrow to accommodate the expected vehicle types associated with the planned events at Yarnton Manor, as they cannot physically pass each other along this public highway.

For example below is an extract from MfS, which illustrates a minimum carriageway width of 4.1m, which is required for two cars to pass each other. For a car and HGV to pass each other a 4.8m carriageway is required.






Figure 7.1 Illustrates what various carriageway widths can accommodate. They are not necessarily recommendations.

4.3 It was observed on that site that while the footway provisions along Church Lane are sporadic, a number of pedestrians were seen using Church Lane and the surrounding public rights of way routes (leisure walking). Any increase in traffic movements associated with the proposed premises licence can only have a detrimental impact upon the existing pedestrian environment along Church Lane; and increase the likelihood of pedestrians and motor vehicles coming into conflict due to the lack of proper footway provisions and suitable areas for pedestrians to take refugee.

5 Local Concerns & Observations

5.1 In respect of the proposed premises licence being sought local residents have observed a frequent number of large vehicles using Church Lane that are associated with Yarnton Manor. Some of which are shown below and are attached to this report as Appendix A.











5.2 It is acknowledged some of these traffic movements are linked to the permitted use of the site. However, it can be clearly seen these observed vehicles are physically too large to be accommodated by Church Lane and any increase in their frequency should <u>not</u> be accepted and resisted on highway safety grounds.



6 Local and National Policies

6.1 While the proposed premises licence to Cherwell District Council is not subject to a formal planning application, consideration to Cherwell District Council, Oxfordshire County Council and national polices should be given, especially the polices related to safe and suitable access. Such as:

Adopted Cherwell Local Plan 1996 (saved policy): Policy TR7

"Development that would regularly attract large commercial vehicles or large numbers of cars onto unsuitable minor roads will not normally be permitted".

Oxfordshire Local Transport Plan 2011-2030: General Policy G3

"Oxfordshire County Council will work to ensure that the transport network can meet the requirements of the county's world class economy, whilst protecting the environment and the amenity of Oxfordshire residents".

Oxfordshire Local Transport Plan 2011-2030: Policy SD1 Supporting Development

"Oxfordshire County Council will seek to ensure that:

- the location and layout of new developments minimise the need for travel and can be served by high quality public transport, cycling and walking facilities;
- developers promote sustainable travel for all journeys associated with new development, especially those to work and education, and;
- the traffic from new development can be accommodated safely and efficiently on the transport network".

National Planning Policy Framework (NPPF)

Government planning policy on transport is set out principally in the National Planning Policy Framework (NPPF). This provides advice on how local authorities should integrate land use and transport, particularly through the development process and promotes sustainable transport. Its key objectives are to ensure:

- The opportunities for sustainable transport have been taken up depending on the nature and location of the site, to reduce the need for major transport infrastructure;
- Safe and suitable access to the site can be achieved for all people; and.
- Improvements can be undertaken within the transport network that cost effectively limit the significant impacts of the development. Development should only be prevented or refused on transport grounds where the residual cumulative impacts of development are severe.



7 Summary

- 7.1 The location of the site being promoted for the premises licence is unsuitable due to the design of the local highway network that serves Yarnton Manor and the nearby residential properties in the area.
- 7.2 Measurements on site have confirmed that the majority of Church Lane only has a width of just over 3m, which is not sufficient enough to physically allow two motor vehicles to pass i.e. 4.1m or 4.8m is required.
- 7.3 The traffic generation and impact from the proposed events associated with the premises licence is expected to be high due to experiences from other known events within Oxfordshire, which is a highway safety and capacity concern.
- 7.4 Church Lane is well used by pedestrians using sections of the footways provided and the local pubic rights of way routes. Any increase in traffic movements associated with the proposed premises licence can only have a detrimental impact upon the existing pedestrian environment along Church Lane, and increase the likelihood of pedestrians and motor vehicles coming into conflict.
- 7.5 Photographic evidence has confirmed that Church Lane cannot accommodate the existing traffic movements generated by Yarnton Manor and any additional traffic movements associated with the premises licence will only have a detrimental impact on the safety of users of this public highway.
- 7.6 The proposed site appears to be contrary to the current and emerging local and national policies for the area

8 Conclusion

- 8.1 This Transport and Access Appraisal report provides a robust analysis of the highway and access issues on the local highway network demonstrating that Church Lane is <u>not</u> suitable to accommodate the proposed events to be associated with Yarnton Manor.
- 8.2 Given these findings the grant of a premises licence is likely to significantly increase the risks to public safety and the noise generated by the increased traffic is likely to impact adversely on the local environment.

Dear Residents

We are offering this meeting today as an opportunity for concerns to be raised, and these addressed, in relation to the Estate's premises licence application listed for hearing by the Licensing Sub-Committee of the Council on 28 July and in relation to the Winterwell event on 29 August 2015.

We appreciate that this meeting was arranged at short notice. However today was chosen because, as you may know, the hearing date for our premises licence of 28th July has only recently been scheduled by the Licensing Sub-Committee, and to get this session in a reasonable time ahead of that date we have had to fix a date early in July. Logistically the date had to be 4th July, because the Manor (otherwise full of students) is empty for a changeover day with one group of students having left this morning and another group not arriving till tomorrow morning.

Premises Licence Application

We have received a number of enquiries about our recent application for a premises licence to show films, play recorded and live music (to the extent now required) and (where appropriate) serve refreshments and alcoholic beverages (all regulated activities) at the various functions that will take place at the Manor over a normal year. The question has been asked: What are our intentions in this, and what might be the impact of what's proposed on the surrounding community if granted?

We must stress that we are primarily applying for administrative reasons. A single licence for regulated activities is valid for a year, and thereafter is subject to an annual fee. Having a single annual licence in place saves our having to make an application to the Council by temporary event notice (TEN) each and every time a function is to take place during the year (but see below as to the maximum permissible of these).

We have already applied for and been granted TENs for the 6 presently-anticipated number of events and functions associated with our student summer courses. These are non-alcoholic functions usually associated with the ending of a course for a batch of students e.g. a graduation disco. 2 of these have taken place already on 19th June & 3rd July without a problem.

But we need to be flexible, as we are setting up here an all-year-round educational centre, and groups of students may be having graduation discos or similar, or functions may be arranged for them, all through the year, or scheduled dates may need to be changed.

To date the maximum number of TENs that might be applied for in a year is 12. Parliament has now increased this to 15 in any calendar year. Beyond that number, a single annual premises licence is required.

Functions to be held are not only student-related events. The Manor has for a long time been pleased to make its facilities available to couples for weddings, for example, averaging a small number of these during the year. Residential conferences may also be held, to which functions attach and there may be other functions or events – for example a few years ago the Manor hosted the St Hugh's College Annual Ball.

Without a premises licence, we would be unable to carry on our business of this kind beyond the maximum permissible number of TENs during a year. All who have visited our fine Grade 2* Listed Jacobean building will have no difficulty imagining the cost of maintaining its fabric in a state that can be enjoyed by future generations. As in every other sphere of public life, we need to be able to make good use of our asset, provided our activities are run in a way that is appropriate and sensitive to the interests and amenity of our neighbours.

Another need for the premises licence is in relation to the showing of films for educational (and commercial) purposes. At present we have a licence in place for the copyright aspect of showing films, but we don't have a licence for the actual showing of films (e.g. as a part of our educational courses – again, to the extent that this is required by law).

Separately, we had thought that the showing of films (such as vintage movies) on a giant inflatable screen might be something the village might find attractive down the line. We would not be intending to do this regularly, perhaps once or twice a summer, but currently permission for this would need to come out of our annual TEN allocation.

We have closely followed the guidance given by Cherwell District Council in their application documentation by:

- Posting up a copy of our application on the gate outside the Manor on the blue A4 paper supplied by the Council. This notice has been in effect since 6 June.
 - Submitting a copy of the application to the Oxford Mail for publication for Yarnton residents and people further afield to see.
- Publishing the application in the Oxford Mail online for web-viewers to see.

Copies of published notice and the application are attached. Their prescribed format does not allow for much explanation to be included. The prescribed notice is just a bare, factual statement of the types of regulated activities and the hours applied for. So just reading it on its own may give cause for concern. This is perhaps particularly so in relation to the hours and days applied for. To explain, though:

We may want to be showing <u>films</u> (mostly to students) <u>indoors</u> on any day of the week, so permission for this 5.00 pm to 2.00 am Monday to Sunday has been applied for.

Outdoors (practically speaking in the rear gardens of the Manor) permission applied for to show films has been restricted to 5.00 pm to 11.00 pm Monday to Sunday.

Permission to play <u>Recorded music</u> (e.g. music played from CD) <u>indoors</u> has been applied for (very often at functions for students, other residents & guests) on Thursdays to Sundays 1.00 pm to 3.00 am.

<u>Outdoors</u>, the permission for <u>recorded music</u> has been restricted to between 1.00 pm and midnight Thursdays to Sundays inclusive.

The playing of <u>live music</u> (any kind of live music from a concert pianist to a dance band) is a different regulated activity. Permission for this has been applied for <u>indoors</u> between 1.00 pm and 3.00 am Thursdays to Sundays.

Outdoors (which means in practical terms in the rear gardens of the Manor) permission to play <u>live</u> music has been applied for between 1.00 pm and midnight Thursdays to Sundays.

Associated with the above activities <u>indoors</u> or <u>outdoors</u>, permission to supply <u>late-night</u> refreshments has been applied for Thursday to Sunday 11.00 pm to 3.00am.

Again, associated with the above activities <u>indoors</u> or <u>outdoors</u>, permission to sell <u>alcoholic</u> <u>drinks</u> (e.g a cash bar for departing residential conference attendees) has been applied for Thursday to Saturday 1.00 pm to 3.00 am, with Sunday those hours restricted to 1.00 pm to midnight.

None of this means that we have the intention of showing films, playing music, selling refreshments and selling alcohol on every one of those permitted days during all those permitted hours. These days and hours applied for are an overall permission for regulated activities on occasions to be authorised by the required licence.

The guidance that we received from the Council is to apply for days & hours which are sufficient to include regulated activities at all types of anticipated functions or events, so as not to need to re-apply for variations of the licence terms every time a function is booked which might need regulated activities to be running outside the shorter hours originally applied for. So, for example, it's very unlikely that we would be running a film show for young students till after midnight, and no alcohol would be supplied to them in any event, but if one of the Oxford Colleges (as St Hugh's have done in the past) were to want us to host their May Ball, or a wedding or birthday party hosted at the Manor were to want their reception to go late on a light mid-summer night, then that 3.00 am longstop time might be needed.

Essentially, these are longstop hours sufficient to cater for all the different types of function that we envisage we might need during the year.

Winterwell

One of these functions is the hosting of the one-off, one-day Winterwell event on 29th August, when the Manor will be closed to students, run by our events-operating company Winterwell World Limited.

We have already been granted permission for this under a TEN that we submitted. A copy of that grant and the application for it (with confidential details redacted) is attached.

Winterwell is in essence a summer garden party, with music going on into the night, for likely about 350 to maximum 499 people, with associated supply of refreshments, alcohol, and possibly showing of films. Winterwell has been in operation for almost a decade at various venues (including in Oxfordshire) without incident and is run by a team of experienced event management professionals.

In practice an event of this nature is not unlike a large private party, or a wedding, or a function such as a College Ball.

The size of the event will be easily accommodated within the 7-acres of the Manor gardens. We will ensure appropriate security measures and infrastructure are in place to allow the event to run smoothly and without incident. Staff and security measures will be in place to ensure that guests are kept to the designated areas for the event and not allowed to roam around the agricultural fields belonging to the Estate.

We are aware that the outdoor music will be audible to some local residents, and will be taking steps to limit as far as reasonably practicable any disturbance that this may cause. The music will be contained to the back lawns of the Manor, which are surrounded by walls and high trees. The playing of outdoor music will be over by 9.00 pm. After then music will be played indoors.

In relation to traffic and access for the event, we do not think there is likely to be material impact on Church Lane. However, we will be taking advice from an independent traffic consultant on this point at the appropriate time.

Winterwell is open to anyone (subject to security and to numbers) and features garden games, lawn tennis, croquet, picnics, live music and much more. A discount is available for Yarnton residents and anyone interested should enquire via the Winterwell website at www.winterwell.co.uk . Two very worthy charities - *War Child* and *Care International* - are being supported this year, and we hope to raise as much money for them as possible.

General

Primarily, we are an educational company, first and foremost working with the interests of our staff and students in mind. However, as previously indicated, running ancillary events (e.g. during the holiday or low-season) is absolutely fundamental to our business, as it provides needed income to go towards maintaining the Estate throughout the year. This is not uncommon in the Oxford University Colleges, all of which generate extra income when their students aren't on site to contribute towards, for example, increasingly expensive building repairs.

Hopefully the above explanations will alleviate concerns and correct a certain degree of misunderstanding as to what is intended by the premises licence that we have applied for, but this is an open information session and questions are welcome to be asked, through the meeting Chairman, of our representatives present.

We sincerely hope that this can be the beginning of a sustained dialogue between the Estate and its neighbours. Certainly this is our intention.

REVISED REPRESENTATION OF MICHAEL & CAROLINE WILLIAMS

IN RESPONSE TO AN APPLICATION FOR

A NEW PREMISES LICENCE FOR YARNTON MANOR

Introduction and summary of representation

- 1. On behalf of my wife and I on 19 June 2015 our legal advisors submitted a brief representation to the licensing authority objecting to this application for a new premises licence for Yarnton Manor. Having considered further documents relating to this application and taken legal advice, we now wish to take the opportunity to revise and amplify those representations.
- 2. This application, if granted in the terms on which it was made, has the potential to significantly alter the hitherto tranquil nature of the village of Yarnton for the worse. We live adjacent to Yarnton Manor at Kings Retreat, Church Lane, Yarnton OX5 1PY. Together with our near neighbours Mark and Rachel Ponnusamy (of Perry Orchard, 28 Church Lane), Rev Nathan Jarvis (of The Vicarage, Yarnton) and Stephanie Dittos (of Mead Farm, Church Lane) we are the nearest residents to Yarnton Manor. We are the residents of Yarnton most likely to be impacted by any licensable activities that are permitted to be carried on at the premises.
- 3. This application causes us very deep concerns relating to:
 - a. The prevention of public nuisance; and
 - b. Public safety.
- 4. We would respectfully invite the licensing authority to take one of two courses:
 - a. Reject the application in its entirety; or
 - b. <u>If</u> the applicant can produce evidence and suggest meaningful steps that satisfy the licensing authority that they can prevent a public nuisance and secure public safety (and to date they have not), then to grant a premises licence but <u>only</u> to this limited extent and with the following conditions attached:
 - i. All licensable activities must cease at 23:00hrs;

- ii. No regulated entertainment shall take place in any external area (including within a marquee erected in an external area);
- iii. A noise limiting device must be installed and must operate at all times amplified regulated entertainment takes place at the premises. The device must be of a type, in a location and set at a level approved in writing by the appropriate environmental health/noise officer of the Council;
- iv. No person shall be permitted to consume alcohol in any outside area after 23:00hrs on any day;
- v. The premises licence holder shall draw up, and operate all events involving licensable activities in accordance with, a Noise Management Plan and a Traffic Management Plan approved in writing by the appropriate officer of the Council. In the absence of such prior approval, no licensable activities shall be permitted to be carried on at any time;
- vi. No deliveries or collections relating to licensable activities at the premises will take place between the hours of 22:00hrs and 08:00hrs.

Recent history

5. The village of Yarnton is a tranquil and idyllic Cotswold location within the protected Green Belt. People move here, and remain here, in order to enjoy the quiet and peaceful setting it offers in contrast to towns and cities. Many people, including myself, work quietly in their homes during the day as well as using them to reside in. Some of our neighbours have families with young children who retire early to bed on both school-nights as well as at weekends. My wife and I have a 14 year old son who lives with us (and is studying for his GCSE's). He should not be woken up late at night on any day. Given our rather special environment we have a reasonable expectation of being able to quietly enjoy our homes during the day and particularly at night - without the fear or reality of being disturbed in our homes by noisy activity in the nearby Yarnton Manor.

- 6. We are not serial complainers or unreasonable objectors. We understand neighbourly give and take. For some 20 years Yarnton Manor was occupied by the Oxford Centre of Jewish and Hebrew Studies. They were exceptionally good and considerate neighbours. They did occasionally hold receptions at the Manor. On the rare occasion issues arose they were dealt with. At no time did the Centre seek to abuse the premises or risk disturbing their neighbours. They acknowledged the special location and respected it. We had no cause to complain and did not do so.
- 7. There is a striking contrast between the old occupiers of Yarnton Manor and the new ones: Oxford Programs Ltd and their Directors, the brothers William and George Humphreys. The change in ownership took place in or around September 2014. Assuming the applicants acted with due diligence, they took on this premises in the full knowledge that there was no premises licence permitting licensable activities to be carried on at the Manor. They could have had no reasonable expectation they would be granted one given the quiet location of the Manor and its proximity to residential premises including ours.
- 8. The owners operate the Manor as the "Oxford Royale Academy International Study Centre". It has no connection with the University of Oxford or Oxford Brookes University. Although its website promotes "year-long study courses" we understand its primary current offering is running summer school courses between June and late August.
- 9. The Manor building was built in the early 17th century. It has been used as a private residence and then in various guises as an academic establishment. Until this application, it has never been routinely used as a commercial entertainment venue in so far as we are aware. It is wholly unsuited for this purpose as is this location.

Future use of Manor if premises licence granted

- 10. It appears that the new owners now wish to commercialise the Manor and its grounds by seeking the permission of this licensing authority to utilise it as an entertainment-venue able to sell-alcohol, provide live and recorded music and late night refreshment to 03:00hrs on Thursday Sunday. These hours are more akin to nightclub hours and are suggestive of the sort of events they may wish to promote at the venue if permitted to do so by this licensing authority.
- 11. Although the premises licence application suggests more benign and limited uses of the Manor, the grant of this premises licence in the terms of the application would permit major music and

alcohol-led events involving hundreds or thousands of people to take place on Thursdays, Fridays, Saturdays and Sundays each and every week of the year. This cannot be appropriate in our quiet and noise-sensitive residential location.

- 12. The steps proposed in the operating schedule are, with respect, amateurish in their drafting and concept and unenforceable as conditions on a premises licence. In any event they fall well short of steps capable of promoting the licensing objectives. It is surprising that a large venue with the potential to have such an adverse impact on the surrounding area has not submitted a professionally prepared licence application or supported it with the type of evidence one would expect to see, such as full acoustic reports, noise management plans and traffic management plans. It is also unfortunate that the applicants have not arranged proper consultations with the villagers prior to submitting this ambitious and wholly inappropriate application. This unprofessional approach to the licence application does not bode well for the ability of this licence holder to carry on licensable activities in the future without undermining the licensing objectives.
- 13. As an example of what we can expect if this licence is granted, we note that a Temporary Event Notice has been accepted (without objection) for the Winterwell "Summer of 1967" Party to be held at Yarnton Manor on 29 August 2015. Details of this event are published online (see screen-grabs at MW/1 and also http://www.winterwell.co.uk/summer-house-1967-poster/). The event promises "a frolicking, psychedelic, kaleidoscopic jaunt through the heartland of '67. Make like you're heading down to San Fran, hang those free-loving flowers in your hair, pack your swankiest dancing shoes and leave your inhibitions at home in the city". Live bands and DJ's are promised by day with "Winterwell's finest DJ's playing late into the night". Whilst we have absolutely no objection to people enjoying themselves (we were all young once), there is a proper place for such an event. We can say with some confidence that a quiet, residential, Cotswold village such as ours, is not one of them.
- 14. A Companies House search reveals that Winterwell World Limited, who appear to be operating this event, have both William and George Humphreys listed among the Directors (see MW/2). The former is of course, the applicant for this Premises Licence. The latter is his brother. This is why there is reason to believe this specific event might be indicative of the type of events to be held on a more permanent basis at the Manor if this Premises Licence is granted on its current terms.

Public nuisance

- 15. In such a quiet setting as Yarnton, music playing at the Manor can be heard fairly easily in nearby residences. This is the case during the day as well as at night. The 400 year old listed buildings cannot be modified to attenuate the risk of music escape. If events are held in marquees in the grounds, or completely outside, the risk of music escaping and causing a public nuisance to my wife and I and our nearest neighbours is close to unavoidable.
- 16. Similarly if scores or hundreds of visitors attracted to events at the Manor have enjoyed themselves listening to music and drinking alcohol there is an obvious risk, and we would suggest likelihood, that they will make a considerable noise both during the event and when they leave. Previous, but isolated, events held previously at the Manor and in nearby premises (for example Little Blenheim on Cassington Road) confirm that loud voices and the sounds of scores of even well-behaved people in conversation whilst in the grounds of the Manor travel across the land and can be heard in our home and those of our neighbours causing a significant disturbance. The Manor is surrounded by very open, arable farmland and therefore noise travels all the more readily to the homes along Church Lane, Cassington Road and into the village itself.
- 17. The only exit from the Manor is along Church Lane where my wife and I live. If weddings and similar events are to be held at the Manor then this tends to lead to a mass exodus of people all at once at the end of the event (rather than a gradual dispersal of customers throughout the night as experienced in many other types of licensed establishments). This in turn will lead to vehicles queuing up at the junction with Church Lane, the noise of engines revving as they pull out, and the honking of horns as frustrated people all try to leave at once but are restricted to doing so by the sheer number of vehicles trying to use a narrow track. Of course, none of this nuisance will be intended by the drivers, but the disturbance caused to us and our neighbours will be just as real.
- 18. In the warmer months my wife and I often like to relax in our lounge or sleep with our windows open. This is unlikely to be possible if music is playing at the Manor or during a busy event. I do not believe it is reasonable to expect us to change our lives to accommodate the commercial interests of the current owners of Yarnton Manor.
- 19. Ironically, the owners of Oxford Programs Ltd, through their father Mr RA Humphreys, in an unrelated planning objection in October 2014, MW.3a appeared to recognise the "strongly rural" setting of Yarnton Manor and the importance of protecting the Green Belt (see planning objection

- letter at MW/3). It follows from this licence application that the applicants believe these proper considerations apply only to others and not to themselves.
- 20. We hope to obtain further evidence in relation to the potential for noise nuisance caused by this application and will serve it on all parties if it is completed in time.

Public safety

- 21. As noted above the only vehicular entrance and exit to Yarnton Manor is via Church Lane. This is a narrow track which is only wide enough for a single car to travel down (though there are passing bays). Importantly Church Lane has no continuous footpath for pedestrians and nor is there very much lighting on this track. Pedestrians have to walk in the road itself for significant portions of its length. If this licence is granted it can be expected that events will attract far more people in vehicles (cars and coaches) than before needing to travel down Church Lane. These vehicles will come into contact with pedestrians at some point. Students are currently being bussed in on a regular basis and this is already causing issues in Church Lane we have witnessed.
- 22. This increase in vehicular movement increases the risk of injury to pedestrians using Church Lane particularly, but not only, at night. This issue is therefore relevant to the public safety licensing objective. This is particularly so when the applicant has not put forward any considered traffic management plan suggesting how he will control the increased traffic that will result from the grant of this premises licence in a manner that does not jeopardise public safety or cause a public nuisance.

Other points

- 23. To assist all parties I attach a plans that show the proximity of Yarnton Manor in relation to my home and that of my neighbours Mr and Mrs Ponnusamy who live at Perry Orchard, 28 Church Lane and others (see <u>MW/4</u>). I am aware Mr and Mrs Ponnusamy have particular issues with the use of The Orchard area of the Manor because of the location of their home.
- 24. We have been advised that the plan submitted with the application form does not comply with the requirements of regulation 23 of the <u>Licensing Act 2003 (Premises Licences) Regulations 2005</u>. Whilst others may suggest that this defect fundamentally invalidates the application (and legally we make no submission either way), we prefer to deal with this case on its substantive merits at the hearing on 28 July 2015. However we would request that full plans are served by the applicant

that complies with regulation 23 at least 5 working days prior to the hearing so we can all consider them properly.

Conclusion

- 25. We hope it will be apparent from the above that we are neither kill-joys nor die-hards. In its current form this application cannot, we suggest, be granted without undermining the licensing objectives of preventing public nuisance and public safety. In its current state we ask for it to be rejected.
- 26. However it may be that further significant evidence will be produced and meaningful steps proposed by the applicant prior to the hearing. If so then it may be possible to grant the premises licence in a limited way that is more appropriate to this location and takes account of the close proximity of noise-sensitive residential premises. That limited way has been set out at the beginning of this representation but is repeated below for convenience:
 - i. All licensable activities must cease at 23:00hrs;
 - ii. No regulated entertainment shall take place in any external area (including within a marquee erected in an external area);
 - iii. A noise limiting device must be installed and must operate at all times amplified regulated entertainment takes place at the premises. The device must be of a type, in a location and set at a level approved in writing by the appropriate environmental health/noise officer of the Council;
 - iv. No person shall be permitted to consume alcohol in any outside area after 23:00hrs on any day;
 - v. The premises licence holder shall draw up, and operate all events involving licensable activities in accordance with, a Noise Management Plan and a Traffic Management Plan approved in writing by the appropriate officer of the Council.

In the absence of such prior approval, no licensable activities shall be permitted to be carried on at any time;

- vi. No deliveries or collections relating to licensable activities at the premises will take place between the hours of 22:00hrs and 08:00hrs.
- 27. Please note that we will be attending the hearing with legal representation and will wish to amplify this representation by speaking.





I was born in Yarnton and lived there for 46 years until 2003. I know I am no longer a resident of this beautiful village and therefore have to rights to comment on the application mentioned below but PLEASE DO NOT reject this letter before reading further.

I have seen the application from Yarnton Manor asking for a Premises License to allow music to be played and alcohol to be sold to 3am. I would very much like you to take into account the following objection I have with this application.

I come home (I still class it as my home even after all these years) go to Yarnton quite regularly to visit friends and family. Whilst in the village I ALWAYS visit the cemetery located behind the Manor. I have family and friends buried within this cemetery. When I visit I find it a place of peace and tranquility, a place to be able to remember our loved ones. A place to cry, a place to laugh. If the Manor are granted their application then Yarnton cemetery will no longer be what it was and what it was intended to be. A resting place for our loved ones. Can you honestly say this will be the case if the application is approved?.

I am also concerned about the possible overspill of party goers towards or into the cemetery and for the potential for damage to head stones etc. We have all seen it in the media where some young people disrespect other peoples property and behave inappropriately. I would be mortified to arrive one morning at the cemetery to find any damage caused, empty drinking receptacles, human waste or even drunken people from the evening / early morning.

The use of Yarnton Manor as a venue for late night entertainment is not an appropriate one because of the character of the area.

If you are reading this far then I wish to thank you for doing so.

YARNTON MANOR LICENCE APPLICATION

Dear Councillors,

I have to add my voice to the numerous objections that I know you have received in response to this application. I was born in the village, and my family have lived here now for generations. I and my brother and sister, parents, aunts, uncles and cousins all played in the fields around the Manor as children. We have had weddings, christenings and funerals at the church, and my grandparents lived in Church Lane, so I know the area very well indeed.

This is quite simply the most quite, peaceful and historic part of the village. It is the area where the old character of the village is retained. This application has been made with no thought whatsoever as to the locality in question, and with even less respect to the people of the village. It is a typically "lets-ask-for-everything-and-see-what-we-get-pegged-back-to" application, submitted by an organisation that are new to the area and with the sole intention of making money. My concerns are set out below:

- <u>Hours</u> the hours that have been applied for are far too long for a location of this type, are completely inappropriate, as the application (if granted) has no time limits. Also there are no restrictions as to the frequency of events.
- Traffic and Access it is ludicrous to think, let alone seriously base an application on a suggestion, that coaches allowing up to 5,000 people to attend events of this nature, will be even vaguely manageable or practical. At family weddings we have in the past arranged for a coach to take guests away from St. Bartholomew's Church to the reception (approximately 150 people). In addition to the few other cars that were at these events, it was difficult for the coach to access and turn round at the church outside the Manor gates.
- Similar access problems were experienced at my fathers funeral (attended by approx 250 people, when there was standing room only in the Church) in February 2005. Cars had been parked the entire length of Church Lane and ended up parking in The Paddocks, and along the bottom end of Rutten Lane. It was a squeeze to get the hurse and the family cars down to the church, and it should be remembered that this was a funeral where many people walked from the village to attend.
- Should there be an incident at the site requiring the emergency services, what do the applicants intend to do to ensure that access is sufficient so as to allow the site to be adequately accessed?
- Environment as I have already stated, this is the quiet and historic end of the village, with very little housing. It is rural and used by dog walkers and villagers, to gain access to the meadows and cemeteries. The area was not designed to deal with busy traffic, as the road is narrow at best, and an increase in the volume of traffic generated by this application will potentially cause damage to the road and the environment, as well as causing a huge disturbance to the residents of Church Lane, many of whom, it should be remembered are elderly, as the top end of Church Lane includes a small development of retirement bungalows. As well as the traffic and noise pollution (further outlined below) there will also be light pollution.
- <u>Noise</u> I am also concerned about the noise that will be generated by these events. I am aware that tickets are already being advertised and sold on the Internet for an event which is planned and yet not licenced. Yarnton has in the past been close to two "illegal raves". One was held in the area of

Church Lane, during the summer, and kept a large number of local residents at the time awake, with music, whistles and PA systems. At the time my family lived in Bernard Close. I also remember my father returning in a disgusted and angry state from his usual dog-walk the following morning, and commenting that the fields around the back of the cemetery and the footpath leading to it, had been turned into a public toilet. People were still wandering around drunk and high during that Sunday morning, causing a disturbance to the village.

- The second rave occurred at Worton, which is the next hamlet along the Cassington Road. Again, my family were living at Bernard Close, but again, we were disturbed by the noise and so were our neighbours. It should be noted that Worton is some distance away from the village, and follows that there is a precedent to the amount of noise and disturbance that such an event will cause.
- Classing music as being "inside" when it is housed by a marquee, will not be sufficient to reduce the level of sound so as not to disturb people when they are asleep.
- Although I am fully aware that Cherwell District Council's Environmental Health teams have powers to act if the noise is above a certain level, I am also aware that this may be difficult to control. I am unsure if they have an "out of hours" service, and question whether or not it would be robust enough to cope with the demands which would be placed on it if this type of event is allowed to proceed.
- Noise does and will travel from that end of the village. Many people from the village will be aware that Mr Douglas Charlett (who lived next to Charlett's Tyres, in Cassington Road) had an old fairground steam engine and organ, which has been used at village events over the years, Whilst living in Bernard Close, I can also recall that Mr Charlett used to like to run the steam engine and the organ on a Sunday afternoon, no doubt to keep it running. The residents of Meadow Way and Bernard Close could often hear it playing and I am sure that that was no louder than these parties will be.
- Seasonal I am interested to note that the application application indicates that the summer will be busier than the winters. It follows that the potential for disturbance will be higher as we tend to have our windows open for ventilation as will Yarnton Manor. I also understand that the Manor now houses a "school" and this was the reason given for the attempts to close local footpaths in the vicinity "to protect the privacy of the children". How will such an application support the much-needed "privacy" of the children residing at the school? Will these events only be when their own children will be away from the Manor? Is the applicant really saying that they do not wish children in their own care to be disturbed, but they are more than happy to disturb all their other neighbouring children and elderly residents?
- **Drugs and Alcohol** currently, the village has an annual beer festival held at the Turnpike. This does not go on beyond 12.00, and is attended mainly by people from the village, with a capacity of significantly less than 5,000. It is a family event, with many young children attending. I do not believe from the adverts that I have seen for the planned festival, that the same type of participants will be attracted the events planned at the Manor. The hours of the licence suggest that alcohol abuse will be encouraged, as there would appear to be very little restrictions, and there is no indication of what will be done to prevent drugs being brought into the area, as festivals of this nature are well-renowned for being involved in 'legal highs'. Does the village really need this on a weekly or ANY basis?
- <u>Disturbance</u> although the application asks that music ends at 3am, I note that this does NOT mean that everyone leaves the site at this time of the morning, and even if it did, this would cause further disturbance. What is to stop a 3-day event being held that will allow participants to camp at the site and continue drinking their own alcohol which they may bring with them?
- Anti-social In short, the village does not need this type of event AT ALL. I would ask that the application be refused. Not amended and granted, refused outright. The terms of the application mean that if a funeral is held in the church on Thursday or Friday afternoon, it is at risk of being disturbed by a planned "festival" is that really what bereaved residents really want or need? If you plan a summer wedding at the church, again, you could be drowned out by an event next door at the Manor, just to make your day that little bit more special! To Whom it may concern

As a resident of Yarnton for the last 26 years, I have spent my entire life in this village and have experienced a great number of changes in this time, some positive, others not so positive.

Change, growth and evolution are necessary in all societies but can only be deemed positive when they benefit the residents in the local vicinity. I find it difficult to see the ways in which the granting of this license will benefit the majority of the population of the village. By no means am I against social activities or wider change, however I have personally witnessed the increase in anti-social behavior and blaise recreational drug use and fear that the granting of this license will further exacerbate an ever increasing concern.

As someone who has elderly parents living in the village, their safety and security when strolling their local streets is paramount to me. One of their favorite walking destinations is the track beside the manor, which I am to understand would be a very different walk on Friday or weekend evenings should this license be approved. In addition to this I am soon to become a parent myself and I must look to the future and consider the environment in which I will be raising my own child. I can not fault the upbringing I had in Yarnton and would recommend it as an ideal place to start a family, however the knock on effects that would undoubtedly emerge from the granting of this license would bring this into question.

To clarify, my issue itself is not with the license itself, but with what the license will lead to. Yarnton is not built or capable to deal with the sheer number of people that are estimated to be attending these events. We currently have two local pubs, neither of which cause any local residence cause for concern, because they are in tune with the village. 5,000 revelers descending on our village on a regular basis would be catastrophic on several levels. The traffic, litter and drunken behavior would undoubtedly permeate throughout the village and wouldn't be secluded purely to the Manor and it's grounds. Drunken and disorderly behavior, noise pollution and traffic congestion along Cassington Road and Church Lane are the obvious areas for worry. However we must also not overlook the potential for crimes to be committed. Assault and battery, minor theft and vandalism are the common ones that spring to mind but there would also be a real opportunity for the trafficking and supply of controlled substances. This is something I am sure none of us want in our village, however the events that are being suggested at the Manor are synonymous with this illegal drug market and unfortunately the authorities tend to overlook the use of controlled substances at these events - take Glastonbury for an example. We do not want Yarnton to become a place where recreational drug use is the norm and accepted, our young population does not deserve to be handicapped in such a way and our older population should not be burdened with the worry of the side effects.

I am sure that those who have the final say on the approval of this license are not residents of Yarnton or even have any form of association with the village. However I must draw on you to empathize with us and imagine if your local area was on the verge of this decision. The place where you had built your home, where your children slept at night, what if that was potentially going to be disrupted in an unprecedented

way, would you still think it was unreasonable to oppose the granting of the license? Somehow I highly doubt it.

We are residents of Yarnton and live close to Yarnton Manor. We have recently become aware that a Premises Licence is being applied for at Yarnton Manor, which would allow large numbers of people to gather at events with music to be played, and alcohol to be sold and consumed, until 0300h.

We would like to object to the above application. Yarnton Manor is a small 17th Century Manor House in a quiet location, offering educational programmes and summer schools, and as such it is unsuitable for large numbers of people at late night entertainments. It is accessed by the narrow Church Lane and some of this is only on foot; the sheer numbers of cars being parked in the areas around the Manor would be significantly high, causing potential damage to roadsides, and possibly other vehicles themselves, and increasing the risk of accidents and harm to local residents. The area is entirely unsuitable for the passage of large vehicles such as coaches and lorries.

We are aware that the Premises Licence would allow for about 5000 people to gather at Yarnton Manor. This is far in excess of a suitable number of people at this site. It is likely that there would be enormous traffic problems for local residents on the day of an event. There is no indicated dispersal arrangement in place for events coming to an end, or in the event of an emergency. Critically, the licence sought also grants music to be played outdoors and the ensuing noise would carry across the whole village until 03.00am; this would be intolerable to all local residents. This noise disturbance, a clear public nuisance, would be of primary cause for our objection. Even if music is inside, loud music will still travel outside, and then when the music does finish (in the middle of the night), the noise would continue from people leaving an event, possibly loudly if alcohol has been consumed. It should be borne in mind that most residents in Yarnton are working people and therefore respect for calm privacy and the possibility of going about one's daily business unhindered should be respected. If people were to gather at Yarnton Manor in

such large numbers, there would inevitably be a problem of alcohol abuse and ensuing anti-social behaviour, increased litter and rubbish, in addition to the threat of drugs being brought into the area; it is well known that festivals can attract the use of 'legal highs' in addition to other illegal substances.

Finally, there seems to be little or no controls indicated in the proposal for a licence. There may be lighting shining onto or into properties. There is little control on whether or not children attending the events would consume alcohol unchecked, or indeed whether some events would be suitable for children at all. There is certainly a serious concern about child safety, and general public safety, at an event with such large numbers, continuing until 0300h.

It should be noted that close-by Pixey and Yarnton Meads are Sites of Special Scientific Interest (SSSI) notified under Section 28 of the Wildlife and Countryside Act 1981. Increased human activity in adjacent sites such as Yarnton Manor will pose an increased threat to wildlife. These areas are already under significant pressure caused by the expansion of Worton Park and the new solar panel fields, not to mention new housing estates.

Dear Madame/Sir,

I write to urgently object to the proposed application to Yarnton Manor Licence Application. I feel that the proposed events are inappropriate for Yarnton village, the village is currently a peaceful and pleasant place to live for young and elder alike. I feel that the proposal for such large gatherings of people are unrealistic and likely to impose hugely on the current residents in the village. The little roads around Yarnton can already be busy at the best of times and I feel that the vehicles brought by the proposed 5000 people are likely to be noisy, unsafe and incredible inconvenient taking up the road and parking spaces. As we are all aware the Manor is situated very close to the village church and graveyard- an area of cultural and social importance to many, to have this tarnished by noise and disturbance is not acceptable.

I believe the proposed gatherings are not to finish until 3am in the morning, meaning many villagers including those who rise early to commute to a long day of work and those with young children are likely to have a disturbed night of sleep from the late night noise. I am also concerned about the potential for damage to land and property by those under the influence of alcohol who will be leaving the premises late at night. I note the application has no mention of the lighting for these late night events which causes me concern as obviously strict security lighting would need to be very bright and would naturally have an impact on those houses nearby offering increase light pollution in an area which is normally peaceful late at night.

I feel the proposal has failed in many ways to mention how potential issues with noise, lighting, overcrowding and property damage would be addressed. If this proposal is of a serious nature I feel there needs to be appropriate risk assessments undertaken and an outline of how potential issues may be dealt with in a way which would be acceptable to the current residents of Yarnton.

I am a young professional living in the village and I am not completely adverse to change but I feel in such a small community any major change must be in keeping with the feel of the village and made in agreement with the residents. I am concerned that future potential residents will be put off buying houses in the Yarnton area if there is to be a high risk of noise pollution and disturbing behaviour. Many of those moving to the village are coming to retire in the peaceful setting or to settle down with young families, surely they will be put off by the proposed event. Finally if there is going to be a resulting financial gain for the Manor (which clearly there will be - I note Winterwell festival is charging 80pounds per head) at the cost of local resident convenience and comfort it must be recognised that the community will require compensating for this.

I am grateful that the above will be taken into account when considering the proposal as it stands and I am confident that Cherwell District council will see the potentially negative impact it could have on our pleasant and peaceful village.

My wife and I live in Yarnton (at 2 Little Blenheim Yarnton, Kidlington, OX5 1LX) less than half a mile from Yarnton Manor and would like to object very strongly to the application to stage events there.

Church Lane containing the church and the Manor is the peaceful historic heart of the village. It is a narrow cul-de-sac entirely unsuited to receiving thousands of visitors at once. Their presence and the resulting traffic congestion and noise will cause a serious public nuisance, leave us open to antisocial behaviour, and present a danger to pedestrians and drivers.

We use the narrow lane leading past the church and the manor for recreational walking frequently, almost daily. Staging large events there lasting most of the day and night will prevent inhabitants from using the lane and the nearby area for walking as they have always done, an amenity which the owners of the Manor have already degraded to some extent by unjustifiably closing some footpaths, ironically on the grounds of child protection. I think flooding the area with strangers and having alcohol on sale most of the day and night is a threat to child protection in our village.

As a resident of Yarnton, I wish to raise the following objections to the above application:

In view of the fact that the owners of Yarnton Manor have closed well walked footpaths on their property to the public citing Child Protection issues, it seems very inappropriate to be holding events of the nature for which the licence is applied. The supply of alcohol until 3 am could subject local residents to antisocial behavior and noise.

Church Lane, which leads to Yarnton Manor, is very narrow and only has footpaths for some of its length. Traffic attending events at the Manor would cause horrendous congestion and problems for residents in Church Lane and people attending church either for services or weddings, funerals, baptisms, etc. and those visiting the cemetery.

Park Close, which leads off Church Lane, contains sheltered homes for elderly residents (of which my father is one), who would be particularly affected by any disruption. Carers and emergency services could also be subjected to delays and parking problems.

Noise from live music and films would adversely affect residents living in the vicinity of the Manor and would also carry across the whole village especially as the licence application covers events out of doors and until the early hours of the morning.

Just because music will be 'inside' does not mean that this will not be a problem; music in a marquee would be classed as being 'inside'. The application indicates that the summer will be busier than the winters and this means that the potential for disturbance will be higher as we tend to have our windows open for ventilation as will Yarnton Manor.

Although there is reference to a festival, there is no indication of what will be done to prevent drugs being brought into the area.

The use of Yarnton Manor as a venue for late night entertainment is not an appropriate one because of the character of the area.

The application does not offer effective conditions to control the potential problems and the hours that have been applied for are far too late for a location of this type. There are no real limits on how often events can take place and to allow up to 5,000 people to attend events is excessive. Even a few hundred people would be excessive for our very small village.

I live at 92 Great Close Road, Yarnton, OX5 1QR. I am writing to raise objections to the premises licence application by Oxford Programs Limited for Yarnton Manor.

Context

Yarnton is a quiet, peaceful and harmonious community of around 3000 people. For the 18 years I have lived here it has maintained extremely low levels of anti-social behavior, disorder and crime.

Over the past few years Yarnton has positively embraced a number of commercial and residential developments without losing its core character. This has largely been achieved by all parties working together for their mutual benefit.

However Oxford Programs Limited, the new owners of Yarnton Manor, have not so far proactively engaged with the village over important changes that impact on residents.

They appear disinterested in the effect of their operations on their immediate neighbours and the wider village community. The submission of this licence application without first sounding out local views and seeking to understand or alleviate concerns is indicative of this.

Consequently there can be little confidence that Oxford Programs Limited would take the necessary steps to eliminate or control the significant adverse impacts on the village associated with the matters covered by this licence application.

It is with this context in mind that I wish to raise the following objections to the above premises licence application.

Objections

The supply of alcohol and running of certain events until 3am will inevitably increase antisocial behavior, noise and possibly even crime in Church Lane and elsewhere in the village.

Yarnton Manor is accessed via Church Lane, which is very narrow and does not have footpaths along its entire length. Events at the Manor of the scale and frequency covered by the licence application would result in a huge increase in vehicles and pedestrians using Church Lane. It will also result in larger vehicles regularly using the lane to service these events.

This will therefore cause substantial congestion and disruption for residents in Church Lane, the surrounding area and for people attending services, weddings, funerals etc. at St Bartholomew's Church, which is adjacent to the Manor. It will also inevitably increase the likelihood of accidents and injuries, possibly serious.

Noise from outdoor music (1pm to Midnight) and films (5pm to 11pm) will clearly have the greatest adverse effect on residents living in the vicinity of the Manor and people attending the Church. Noise from indoor music (1pm to 3am), has the potential to cause greater disruption and distress if, for example, it is in a structure like a marquee that provides little or no noise attenuation.

All these sources of excessive noise would also affect large parts of the village, especially at night when it carries further. This would be particularly worse in the summer, when the majority of events are likely to be held, because of people having their house windows open for ventilation.

There have only been a couple of poorly managed music events elsewhere in the village during the time I have lived here. However, these have shown how far noise of this nature travels across Yarnton and how disruptive/intrusive it can be for residents.

Park Close, which leads off Church Lane, contains sheltered homes for elderly residents. This vulnerable population could be particularly affected by the reasonably foreseeable disruption, disturbance and disorder that will be created if this licence application is approved. Carers and emergency services could also be subjected to unacceptable delays and parking problems.

I hope you will take these objections into account when considering this application.

I am writing to strongly object to the application submitted by Yarnton Manor for a new premises licence. The Manor, although located in a reasonable amount of land, is not in a remote setting. It lies at the heart of the village, next to the church and the burial ground, which form part of the bedrock of Yarnton. I understood the Manor had been purchased and set up as an educational centre, a place of learning and study, not as an events venue. Whether or not this would constitute a change of use is, at the moment, a secondary issue for me. My main concern and objections to this application are as follows:

- Noise pollution: this would affect not only the residential housing in Church Lane but across the village as sound carries particularly in the summer. This would include not just the music but the attendant sounds of traffic, setting up, taking down, talking, shouting and laughter. The hours during which this would be permitted are excessive and particularly the notion that this could take place on a Thursday evening when for most people Friday would be a working or school day. It would also impact on people using the two pubs as such noise is likely to dominate the entire village.
- 2. Safety and Security: inevitably large events selling alcohol for a continuous period of 12 hours or more are going to create problems with unruly behaviour and an influx of outsiders with little or no respect for the village and its residents. This is bound to spill out of the Manor grounds and into the village itself. Are the police able to offer an additional presence in the village on such occasions? Thames Valley Police have also expressed a concern in the Yarnton Village News about drugs coming into the village, monitoring and preventing this during events would place them under increasing pressure.

If people are consuming alcohol presumably they should not be driving, so how will they arrive and leave? This has implications for the bus service and/or coaches. Are the roads, particularly Church Lane and Cassington Road, suitable and sufficiently robust to deal with a heavy volume of heavy traffic? If people do bring cars, it is not clear there is sufficient parking on site in which case, again the village would suffer from overflow parking and this would create more noise pollution as people arrive and leave.

3. I am also concerned about the impact of such events on the children of Yarnton – the younger teenagers, particularly - who would be attracted to the noise, alcohol and 'excitement' and yet are not old enough to behave responsibly. I realise these are threats they face in the real world but to have it on their doorstop and so accessible would seem to me to be placing an unreasonable temptation in their path. Even if they were prevented from gate-crashing by security forces they are still going to be vulnerable to an influx of visitors who are here purely for 'fun' and my main concern is that 'fun' these days has many dark connotations - drugs and excessive alcohol consumption to name but two. It is impossible to police such events to ensure the complete safety and security of all those attending and although it would be the Manor's responsibility to prevent gate-crashers I frankly cannot see how they can guarantee to stop inappropriate interaction between their visitors and our children.

My understanding is that the village is not opposed to change in principle, and indeed it has grown and developed over recent years. But the residents will react very strongly to change which threatens the identity, security and life of the village and benefits no-one - other than a commercial organisation bent on maximising profits.

Yarnton Manor is situated in Church Lane which is a single track road with a footpath that only goes some of the way. This lane also leads to residential houses, the Church and graveyard. The licence that is being applied for can allow up to 5000 attendees and we feel that even a few hundred will cause issues with traffic and parking in and around Church Lane. We feel that this could be an issue to public safety as the amount of traffic necessary for the amount of guests would greatly hinder any access for emergency services. It would also be a nuisance for people attending church services and weddings and funerals and those wishing to visit the graveyard, many of which are elderly.

We are also concerned regarding the security that will be provided at these events as this type of event with many attendees and outside music is a magnet for 'uninvited guests'. Noise from live music and films would adversely affect residents living in the vicinity of the Manor, and would also carry across the whole of the village. I understand that the application is for out of doors events as well as inside, (even if it is in a marquee, this would still be a problem).

We have elderly sheltered accomadation in Park Close, which leads off Church Lane, they would be particularly affected by any disruption, carers and emergency services could be held up due to gaining access to Church Lane, once the crowds and their vehicles start to arrive.

As they are planning to have alchohol until 3 am, it is likely that many local residents would be subject to antisocial behaviour and noise.

Church Lane which leads to the Manor is very narrow, with only a few passing places to pull in to. This in its self would cause major problems for people attending church for services, weddings, funerals, baptisms, etc.. The new burial ground is also placed just behind the Manor, and we feel that if anyone wished to visit the graveyard when they are holding their events then there would be no quietness for contemplation. encourage these types of people to come to Yarnton.

Who will control the traffic and the crowds once these people arrive. How will they disperse or make their way to where they will be camping. Who will clear up the rubbish outside of the Manor vicinity.

We would urge you to seriously consider our points raised as Yarnton is a very peaceful friendly place to live. We can't help but feel the allowance of this application would spoil what we have here, the police have enough problems dealing with issues in and around Yarnton, without adding to their burden and budgets.

I would like to object strongly and urgently to the application made by the new owners of the Yarnton manor. Having regular music events, serving alcohol til late is clearly inappropriate for the area.

- Yarnton manor is situated at the end of a small quite lane. It is not at all suited for heavy traffic. Musical events will create lot of traffic with coaches which will damage the lane. There will be risks of damage to the road at great cost to the local authority to repair and therefore tax payers. There will risks of damage cars and any other oncoming traffic at great cost to Thames Valley Police to investigate and therefore tax payers.
- When people late at night will want to get back home, this will create more traffic in the early hours of the morning with the inevitable risks of people hanging around the village in some various state of intoxication.
- There will therefore be an increased risk of anti social behaviour. This again will be another drain on public services like Thames Valley Police. We wish to express out objections to the premises licence which, if granted, would allow up to 5000 people to attend events. Even a tenth of this number of people would cause considerable congestion and noise in such a small village with narrow roads accessing the Manor House. Noise and light pollution would be inevitable given that music can be played and alcohol served up until 03:00. From our location in Cassington Road we can already hear noise from the quarry which is further away than the Manor House as it carries so easily across the intervening field, particularly, now that many trees have been cut down. In addition, there has been a breakdown in trust between the owners of Yarnton Manor and the village residents. They have recently, without consultation, closed down many footpaths which have been regularly used by residents for over 50 years. They cite child safety as a reason for closing the footpaths as under 18's will be attending their educational courses although there are no regulations requiring this. Despite holding a public meeting on 4th July at the Manor to address residents' concerns, they failed to answer questions as to what type of events they would be holding, how often they would be held and why licensing needs to extend until 3am on three days a week.

We believe that the character of Yarnton, which is a small, peaceful village, would be markedly altered by the intrusion of so many visitors drinking alcohol and listening to music on potentially a weekly basis. As a resident of Yarnton (my address is 28 Spencer Avenue, Yarnton, OX5 1NG) I wish to raise the following objections to the above application:

The hours that have been applied for are far too late for a location of this type. The area is generally very quiet and noise from live music and films would carry across the whole village especially as the licence application covers events out of doors and until the early hours of the morning. The application indicates that the summer will be busier than the winters and this means that the potential for disturbance will be higher as we tend to have our windows open for ventilation. Previous experience of the outdoor event at Little Blenheim a few years ago clearly shows this.

I am also concerned about the noise and rowdy behaviour from people leaving events especially considering that up to 5,000 people may be allowed to attend and may have drunk significant quantities of alcohol. I think this number is excessive for our very small village. To require such a large amount of people to leave at 3 am is likely to cause significant disturbance.

In addition to noise, traffic attending events at the Manor on this scale would also cause horrendous congestion and problems for residents in Church Lane and the roads leading to it. Church Lane, which leads to Yarnton Manor, is particularly unsuitable for this level of traffic as it is only wide enough for one car in either direction and only has footpaths for some of its length.

Finally in view of the fact that the owners of Yarnton Manor have closed footpaths on their property to the public citing Child Protection issues, it would seem very inappropriate to be holding events of the nature for which the licence is applied as some of the events are clearly only suitable for adults.

The use of Yarnton Manor as a venue for late night entertainment is, in my view, simply not appropriate.

The owners of the Manor are newcomers to the village and have not previously held an event there requiring a Licence for the provision of Live Music, Recorded Music, Films, and the supply of Alcohol during the afternoon until late at night and into the following morning, so any adverse effect on Yarnton residents cannot yet be assessed, but may include disruption due to noise and volume of traffic, alcohol-fuelled disturbance and/or disturbance caused by outdoor live or recorded music (or indoor if 'indoor' is in a marquee),

The only access to the Manor is Church Lane which is a narrow country lane and only has a footpath in places and only one passing place. The amount of traffic that will be generated by the numbers the applicants aim to attract will inevitably cause noise and inconvenience not only to the residents of Church Lane but the surrounding roads in the village. Given the Manor's close proximity to the Church it could also adversely affect churchgoers, especially those attending weddings or funerals.

Live or recorded music, especially if amplified, could also present problems to those not just in the immediate neighbourhood (and the bungalows in Park Close are classed as sheltered accommodation) but much more widely across the village.

The provision of alcohol from afternoon until the early hours of the morning could present other problems of disruption to residents, unless those attending the event are able to remain at the Manor until the effects of the alcohol have worn off.

We are residents of Yarnton who live a few hundred metres from Yarnton Manor at 30 Pixey Close, Yarnton, KIDLINGTON, Oxon, OX5 1FY.

We wish to object in clear and strong terms to the Yarnton Manor licence application. We have secondary concerns about this licence adversing affecting the welfare of children and giving rise to risks in terms of crime and disorder. The Oxford Royale Academy has been endeavouring to block access to long-used footpaths on child protection grounds and it is not logically consistent for the Academy to be seeking a licence for large numbers of people late into the night and the early hours of the morning. Such large numbers of people consuming alcohol in a fragile village environment also risks giving rise to crime and disorder to which Yarnton would not otherwise be subject.

Our primary concerns are however public safety and the prevention of public nuisance. Yarnton is not urban or even suburban Oxford. It is a quiet village and people like ourselves come to live here precisely to enjoy this quiet especially in the evening and at night. Noise carries a long way and the noise from musical events or films at the Manor would badly affect a very substantial number of residents certainly on the southern edge of Yarnton like ourselves but probably much more widely across the village. Large numbers of people leaving events either on foot or in cars would similarly cause unacceptable levels of noise for local residents. Moreover the road infrastructure here and especially in the approach to the Manor along Church Lane from the Cassington Road is wholly inadequate for substantial numbers of vehicles. This is essentially an old single-track road not all of which is accompanied by proper footpaths. The licence would therefore put public safety at risk or, failing that, cause a substantial nuisance by preventing its use by those on foot; many residents wander down this quiet lane at night walking dogs or simply taking the night air, year-round.

We ask that the licence application be rejected on these sound, indeed compelling and legally sustainable grounds.

As a resident of Yarnton (21 The Garth, OX5 1LZ), I am writing to express my concern regarding the above application.

Firstly, I am astounded that someone can think 5,000 people can be accommodated by our roads, especially Church Lane, at the bottom of which stands Yarnton Manor. Church Lane doesn't have a pavement for much of it and is a single lane! The road is used by church goers and, like myself, dog walkers. It is hard to describe the negative impact such an increase of vehicular density would produce. This impact would be the same even if every single one of the 5,000 were in coaches. Coaches attempting to come in and out of the junction on to the Cassington Road would struggle as there is residents parking directly opposite and public safety would be greatly compromised. (not to mention - where on earth would they park??!!!)

Secondly, the hours that have been applied for are very late considering the proximity to residents (especially two nursing homes in the village and senior housing only a few hundred yards up the road). Even where we live, every August we hear the week long thumping of an organised do and that's towards Cassington. We accept it because it is once a year, but if the Manor are granted permission for this licence, the noise would be way too much *on a weekly basis*!! We do not have double glazing on all our windows - there is no way we will be unaffected by the noise and not only will this be an enormous nuisance to us, but to everyone else in this small village - it's simply not big enough to swallow the sound.

I have tried to look at the application on your website, including the minutes from the meeting deciding if they could apply - none of these pages are available, therefore I cannot check to see if any form of control is being put in place. Consequently I must ask you to deny Yarnton Manor the licence. This is a quiet village and I am truly concerned for the safety issues that would arise should you grant it.

Yarnton Manor may appear to be in a relatively remote location, but the noise and disruption from latenight music, with up to 5000 people attending would be absolutely horrendous for a large part of the village.

I must admit, I enjoy hearing the Church bells from my house. The Church is a 10-15 minute walk from my house, and right next door to the manor. However, the idea of live music until the early hours would be incredibly disruptive and will disturb the sleep of myself and neighbours. This will be especially true in the summer, when a lot of people, myself included, sleep with windows open.

I am used to living near the Village Hall, and hearing the odd late-night party- that is part of today's life. But the license being sought by Yarnton Manor is much more excessive and will become a huge nuisance, for myself and others.

Just getting a large number of people in and out of Yarnton Manor will be a great disturbance, even more so when it is late into the night. The only routes out of the Manor would need to go down Cassington Lane or Rutten Lane, both residential areas. There is obviously also a safety concern with so many vehicles going close to places where children play, and people walk.

I am also extremely worried by the possibility of increased crime. You cannot control large crowds effectively, especially when alcohol is involved. There is, of course, an increased possibility of drug-use, including legal highs.

Music 'inside' can also include marquees, so this does not help reduce the problem of noise from live events.

There are many older people who live nearby and are extremely concerned in the village. Of course, I'm sure you will understand that many of those will not be able to get around to expressing their concerns officially, so I am also speaking on their behalf.

I thought Yarnton Manor had been set up as a school / educational establishment. I hope they will stick to this and not be allowed to cause excessive disruption, noise, traffic etc. The application seems to go against what they stand for.
