- (3) place conditions on the grant of premises licence and/or require changes to the details of the permissions sought.

Executive Summary

Introduction

- 1.1 On 24 September 2012, the Licensing Authority received an application for the grant of a premises licence to permit regulated entertainment, provision of entertainment facilities, provision of late night refreshment and Sale by retail of alcohol at Vue Cinema, Bure Place in Bicester.
- 1.2 The Licensing Act 2003 provides a clear focus on the promotion of four statutory objectives which must be addressed when licensing functions are undertaken.

- 1.3 The licensing objectives are:
 - The prevention of crime and disorder.
 - Public safety.
 - The prevention of public nuisance.
 - The protection of children from harm.

The Guidance issued under Section 182 of the Licensing Act 2003 states:

Each objective is of equal importance. It is important to note that there are no other licensing objectives, so that these four objectives are paramount considerations at all times. But the legislation also supports a number of other key aims and purposes. These are vitally important and should be principal aims for everyone involved in licensing work. They include:

- the necessary protection of local residents, whose lives can be blighted by disturbance and anti-social behaviour associated with the behaviour of some people visiting licensed premises of entertainment;
- the introduction of better and more proportionate regulation to give business greater freedom and flexibility to meet customers' expectations;
- greater choice for consumers, including tourists, about where, when and how they spend their leisure time;
- the encouragement of more family friendly premises where younger children can be free to go with the family;
- the further development within communities of our rich culture of live music, dancing and theatre, both in rural areas and in our towns and cities.
- 1.4 For the Licensing Authority to accept a representation as relevant, it must firstly address one or all of the four licensing objectives and the likely effect of the grant of the premises licence upon the promotion of those objectives. The licensing authority must then determine whether or not the representation may be deemed frivolous, vexatious or repetitious and that they have been received within the relevant timescales. The licensing authority can take whole or part of a representation and deem it as relevant, therefore excluding the irrelevant part from the proceedings.
- 1.5 During the consultation period the Licensing Authority received representations from a number of Interested Parties. Full details of all relevant representations received are included at paragraph 2 of this report.

Proposals

1.6 The applicant has proposed to provide the following regulated activities for the days and times specified:

Plays; Live Music / Recorded Music; Performance of Dance; Provision of

facilities for Making Music; Provision of facilities for Dancing;

Monday – Sunday inclusive from 09:00 to 03:00 the following morning, indoors only

Films

Monday – Sunday inclusive for 24 hours, indoors only

Late Night Refreshment;

Monday – Sunday inclusive from 23:00 to 05:00 the following morning, indoors and outdoors

Sale(by retail) of Alcohol;

Monday – Sunday inclusive from 09:00 to 02:30 the following morning For consumption on the premises only

1.7 The applicant has proposed the following opening hours for the premises:

Monday - Sunday inclusive for 24 hours

- 1.8 In addition to the above times, the applicant has requested the following non standard timings for all licensable activities permitted by the premises licence:
 - An additional hour on the day that British Summertime commences
 - From the end of permitted hours on New Year's Eve to the start of permitted hours on New Year's Day

Background Information

- 2.1 A full copy of the application, including plans of the location to be licensed submitted by the applicant is attached at Appendix 1.
- 2.2 During the consultation period, a total of 53 representations were received in respect of this application from 42 individual addresses.
- 2.3 On 24 September 2012, the Licensing Authority received a response to the application from Trading Standards advising they had no objections to the application. A copy of the correspondence is attached at Appendix 2.
- 2.4 On 10 October 2012, the Licensing Authority received a response to the application from Oxfordshire County Council Fire and Rescue Service advising they had no objections to the application. A copy of the correspondence is attached at Appendix 3.
- 2.5 On 26 September 2012, the Licensing Authority received a response to the application from the Anti Social Behaviour Manager at Cherwell District

- Council advising they had no objections to the application. A copy of the correspondence is attached at Appendix 4.
- At the end of the consultation period, Rob Lowther, the Anti Social Behaviour Manager reviewed the responses from interested parties that had referred to a potential for noise nuisance or anti social behaviour coming from the premises. Whilst Mr Lowther still has no objections to the application, he prepared a response in relation to the points raised. This response is attached to the report as Appendix 5.
- 2.7 On 24 September 2012, an email was sent by Laura Morris, Licensing Officer for Thames Valley Police, requesting the applicant amended their application to refer to Thames Valley Police rather than the Metropolitan Police. This was agreed by the applicant's solicitor. Further to this, on 25 September 2012, the Licensing Authority received a response to the application from the Thames Valley Police advising they had no objections to the application. A copy of the correspondence is attached at Appendix 6 and 7 respectively.
- 2.8 By 12 October 2012, 7 objections had been received from interested parties opposing the application. As a result, the applicant's solicitor arranged for a meeting to be held on 16 October 2012 with the applicant to discuss their concerns. The meeting was attended by Mr Kam Dosanjh, Operations Manager for Vue Cinema, Claire Bold, Licensing Team Leader at Cherwell District Council and interested parties who had made representation up until this date.
- 2.9 On 17 October 2012, Claire Bold wrote to all attendees and the applicant summarising the main points that were raised at the meeting. A copy of the letter sent is attached to the report at Appendix 8.
- 2.10 Some of the concerns raised at the meeting were not directly attributed to the premises licence application and were more concerned with the whole development in Bure Place, Bicester. As a result, these concerns have been forwarded to the relevant departments in Cherwell District Council and Oxfordshire County Council to be addressed.
- 2.11 By the end of the consultation period, 53 objections had been received opposing the application. All of the objections were concerned with the opening times of the premises, the possibility of associated noise nuisance from persons leaving the premises on foot and by car, the sale of alcohol and possible disturbance from light pollution. Full copies of all the objections received from interested parties are attached to this report at Appendix 9.
- 2.12 On 23 October 2012, further correspondence was received from Mr Clark-Dunn and Councillor Mould in addition to their initial objections. Copies of this correspondence are included in Appendix 9.
- 2.13 On 23 October 2012, a representation opposing the application and suggesting amendments to the proposed premises licence was submitted by Councillor Lawrie Stratford, on behalf of the local residents. Councillor Stratford's objection is attached to the report at Appendix 9.
- 2.14 A Map showing the location of the premises in relation to the location of the Interested Party properties is attached at Appendix 10.

Key Issues for Consideration/Reasons for Decision and Options

- 3.1 The Licensing Act 2003 states that all licensing matters must promote the four Licensing Objectives, they are:
 - The prevention of crime and disorder;
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm
- 3.2 Representations received have stated concerns in relation to potential issues in respect of the prevention of crime and disorder and the prevention of public nuisance.
- 3.3 Details of how the applicant intends to promote the four licensing objectives in general in addition to specifically related to promotion of the prevention of crime and disorder objective and the promotion of the prevention of public nuisance objective is given below:

An overview of the changes that have been brought about by the introduction of the FSO

The Regulatory Reform (Fire Safety) Order 2005 (FSO) became law on 1 October 2006. The main effect of the changes are a move towards greater emphasis on fire prevention in all non-domestic premises, including the voluntary sector and self-employed people with premises separate from their homes.

Fire certificates where abolished and cease to have legal status.

The Fire Safety Order applies in England and Wales. It covers 'general fire precautions' and other fire safety duties which are needed to protect 'relevant persons' in case of fire in and around most 'premises'. The Order requires fire precautions to be put in place "where necessary" and to the extent that it is reasonable and practicable in the circumstances of the case.

Responsibility for complying with the Fire Safety Order rests with the 'responsible person'. In a workplace, this is the employer and any other person who may have control of any part of the premises, e.g. the occupier or owner. In all other premises, the person or people in control of the premises will be responsible. If there is more than one responsible person in any type of premises, all must take every reasonable step to work with each other.

If you are the responsible person, you have to carry out a fire risk assessment which must focus on the safety in case of fire of all 'relevant persons'. It should pay particular attention to those at special risk, such as the disabled and those with special needs, and must include consideration of any dangerous substance likely to be on the premises.

In response to point 2 as the Responsible Authority for Public Nuisance we are not obliged to consult with those who may choose to object to a particular license application or indeed to represent their views. Our role is to make a balanced professional judgement as to the likley impact of a given application.

Moving on in my view the profile of a cinema audience is quite different to the profile of those individuals who may visit the town centre to consume alcohol and to visit the late night drinking establishments. For the record these people generally attend cimemas as as couples, or in family or friendship groups. People fitting these profiles are not generally associated with crime and disorder.

The sale of alcohol at the venue seems to have heighten residents concerns. I too was concerned when the application was intially received but having made enquiries of the applicants solictors Poppleston Allen and discovered the way in which alcohol is to be provided my concerns were unfounded. Alcohol is to be provided only to customers holding a ticket for a cinema performace. Sales are to be restricted by a time frame prior to the performance. In this way strict control over individual customers consumption and behaviour following consumption is possible.

Having made enquiries in relation to other Vue operations crime and disorder from customers leaving the premises is a signifficantly less likley occurance that from other styles of entertainment venues opening similar hours.

Trying to predict the movement opf customers from premises whose surroundings are not yet established myust be pure speculation. However bearing in mind that cimema customers will arrive at the venue from all four points of the compass it is reasonable to assume that they will disperse in a similar fashion

On 16 October 2012, a meeting was held for local residents who had expressed written concerns over the premises licence application for Vue Cinemas, Bure Place, Bicester to meet with Mr Kam Dosanjh, Operations Manager for Vue Cinema.

During the course of the meeting, a number of concerns were expressed by the residents in relation to the application, namely:

- The noise nuisance that may be caused by people leaving the cinema in the early hours of the morning and the associated traffic noise
- Issues surrounding parking at the Cinema including how much it will cost, and whether people
 will be encouraged to use the car park provided to prevent them from parking on road
- The location of the 'Vue' illuminated sign on the premises and the times this may be in use and the impact it may have upon local houses
- The sales of alcohol and how these will be managed
- The number of times the premises will be open beyond midnight for late night screenings

Mr Dosanjh explained the sound proofing systems in the building and also the nature of the cinema, which will be classed as a 'Vue Light' and hold a maximum of 751 seats throughout the seven screens, incorporating 102 VIP seats. Mr Dosanjh also explained that no alcohol will be sold to any person who does not hold a valid cinema ticket and that alcohol sales will cease half an hour before the end of the last cinema screening, or at 2.30am, which ever is the latest.

As a result of the meeting, all the concerns raised by residents have been forwarded to the applicant's solicitor for their consideration. The Licensing Authority will continue to collate all written objections to the application prior to midnight on 23 October 2012. A tentative date for a hearing to determine the application has been set for 19 November 2012. Full details of the hearing and the procedures to be followed will be sent to all parties after the end of the consultation period.

Thanks for your letter although the salient points are included the issue is much wider. The development and subsequent licence whether it be for the Cinema or others has major consequences on those residing and owning properties so close to this architecturally lacking eyesore!

The provision of a licence will increase the level of traffic and general public within the area and more importantly beyond midnight and no matter what others say these are the foundations for noise and nuisance. Even the other evening local revellers dumped take away rubbish on the grass verges.

The outcome of the licence decision will no doubt have an effect on the value of our properties.

The whole development and subsequent operation of the building will affect local residents more importantly both mentally and physically for the rest of their lives whether it will be via increased noise and local activity or disturbed nights.

The original development as being constructed would have favoured the location of the Cinema closer to Sheep Street side thus reducing impact on residential properties. The fact the bus station was confirmed directly opposite residential dwellings is absurd and ill conceived by those designing and approving and shows little if any consideration for those ultimately affected by the project. Currently we are unaware of bus timetables but have asked that standing buses turn off their engines.

The Council parties deciding for or against the licence are not directly affected by their decision and we the residents do not have the financial capacity to fight an appeal on similar terms. More importantly we are financing these decisions through our taxes, this is very galling!

Traffic signals are to be audible where public crossings are installed and will cause noise throughout day and night a matter which is totally unacceptable and has been raised with developers and County Council.

The parking issue manifests itself in many ways but more importantly on occasions prevent us accessing our properties or traffic being parked in locations that form a hazard on a road which has no pavement.

The approval of such a licence and any contraventions of the law by the general public certainly during the night will not be dealt with as from my recollection there are no Police on the streets. The local police station is part manned only during the day.

There are a number of occasions when we are disturbed by the police helicopter and sirens throughout the night.

Another major issue is light pollution currently all the site temporary lights are left on through the night unnecessarily. Ultimately there is concern as to what final light emissions will be as they will ultimately affect residents during the night.

As residents we are constantly bombarded with reasons to be green little regard appears to have been give to this public town centre warehouse! No doubt extensive new lighting and open door policy with regard to space heating will prevail as per Bicester Village. The burden for green policy always appears to be borne by the domestic resident.

The approval of such a licence will increase the activity in the around the Town any disturbances put a burden on local residence to report in order that they can achieve an undisturbed night or day. This increased burden is unacceptable and morally wrong.

We are currently experiencing the continuous noise from the construction site sometimes as early as 6.00am through to after 6.00pm and more recently on both Saturday and Sunday. The level of noise will continue once the development is in operation. I have written to T Baldry about possible reduction both now and in the future of the Council Tax as compensation, I understand he referred it to the Chief Executive but alas nothing has happened.

If a licence is granted there should be a condition requiring Vue to allow a number of local public events such as theatre dance operatic etc as currently there are no adequate venues for such events.

No doubt this development and its potential ongoing problems re operational hours, noise, traffic pollution and stress may force long standing residents to incur unbudgeted cost of relocating! Is this democratic or morally acceptable? Perhaps the only outcome may be to pursue the issue through the Human Rights Court.

I trust you will take these points into consideration when deciding the licence.

I have just been passed a copy of the e-mail from Stuart and Paula Clark-Dunn re the above (you will no doubt have observed that I was not copied). I thought that it would be useful to correct some of the "facts" they have set out.

Whilst the development is perhaps not the most attractive building in Bicester it is welcomed by the majority of residents

The development whilst promoting considerable more traffic movement when complete is unlikely to cause significant disruption to the lives of those living closest to it. The parking issue does cause concern us particularly if there are charges for evening parking when drivers are likely to seek free alternatives such as Hanover Gardens, Hunt Close etc. I would dispute the allegation that construction runs from 6.00am to 6.00pm. Living in one of the closest houses to the development we are certainly not aware of work commencing prior to 7.30am and on most days finishing at 5.30pm. As for weekend working 7.30am on Saturday until midday is the norm and Sunday has only been worked to facilitate the paving of Crown Walk so that inconvenience to shoppers is kept to a minimum.

For the purpose of the licencing of the cinema the only real argument is that of noise pollution. All of the residents agree that operating into the early hours will produce some noise when cinema goers leave the premises. Up to midnight this is likely to be lost in the general back ground noise however after midnight it can become obtrusive. I believe it would be more realistic to have a cut-off at midnight for at least one year with perhaps an allowance of perhaps twelve "12.01 nights" per year. If these prove that noise is not an issue then it may be possible to extend the number.

Residents generally welcome the cinema as part of the overall development.

Thank you for making arrangements for some concerned residents of Hanover Gardens and I meet with Kam Dosanjh, Operations Director of Vue Cinemas, last week.

Please count this email as an Objection to Vue's application for a Premises Licence for their cinema at Bure Place, Bicester.

I object because:

- 1. The cinema is located opposite residential housing, including retirement housing for older people. The pedestrian exit pathways from the cinema lead directly onto Manorsfield Road, opposite Hanover Gardens. (see map attached). The Cinema will house several screens seating 100-200 people. Each time a film finishes up to 200 people will leave the venue. It is likely that very many of them will exit on foot or by car on to Manorsfield Road, generating a good deal of noise verbal and mechanical. Mr Dosanjh of Vue has confirmed that they expect to regularly screen films after 10pm and often after 12 midnight. This will lead to late night noise as described and will disturb the residents of Hanover Gardens as they try to sleep.
- 2. I am concerned that Cherwell's Anti Social Behaviour Department has not sought the opinions of the Residents of Hanover Gardens before making their comments on the Licence application. I believe that there will be an increased risk of late night crime and disorder in the Manorsfield Road area. Alcohol will be on sale at the venue and, as I have said above, an approved licence for late screenings will see very many people exit the cinema in waves during the evenings. Vue do not plan to have evening security staff. Anti social behaviour outside the venue is likely to be heard and seen by Hanover Gardens Residents, causing them to be scared and anxious in their own homes.

Please let me know when the date and time for the Licence hearing is confirmed.



Dear Claire,

I wish to register my concerns regarding this application, not the actual facility which is much needed in Bicester, but the proposed hours of operation, and its likely implications on residents near and around the venue.

I've met with a number of residents in Hanover Gardens and Hunt Close and listened to their concerns, and I appreciate that the Applicant has had a meeting with Hanover residents where their concerns were explained.

My major worries relate, not what happens within the premises, but the impact on residents before and after performances, primarily around parking, noise, and litter.

I'm content that the issue of noise from actual performances can be managed by appropriate design methodology which will ensure that residents will not suffer.

The cinema building, whilst being built as part of the Town Centre re-development and therefore sits in what might be described as the "retail centre", it also sits very close to a residential area, including Hanover Gardens, a residential centre for old persons. Whilst the residents have to accept a considerable increase in general activity as a result of the new development, most of this additional noise will occur during daytime and evenings.

However the cinema application is seeking to operate 24 hours for film, and up to 3am for plays, live music, recorded music, dance, facilities for making music. Additionally it is seeking permission to provide "refreshments" until 5am, served both indoors and outdoors.

It can therefore be very easily presumed that there will be considerable movement of people leaving in the early hours, (to many this will seem the middle of the night). It is also very easy to presume the mast majority of these people will leave and return to their cars, with the obvious resultant noise. (Cars doors etc.)

Local residents expect, with good reason, that many will have parked in adjacent roads, rather than pay in the new car park.

However the situation is further exacerbated by the fact that the cinema is seeking to serve alcohol throughout performances, albeit to cease serving 30 mins prior to the end of the performance.

I'm sure we all acknowledge that when people have been drinking, over a prolonged period they are likely to create "more noise", and experiences elsewhere show that post "last orders" in areas that have pubs and clubs residents have to endure considerable noise, albeit for a relative shorter period.

With this application residents are likely to be subjected to this noise through the night.

An additional concern, specifically for residents of Hanover Gardens, relate to the sandwich bar, Subway. It is believed that they currently have a 24 hour licence to serve food. To date this has not been exercised, presumably insufficient demand.

However with a cinema, operating right through the night, it's not unreasonable to presume that Subway will review it's actually hours of operating. This would almost certainly create more disturbance, and of course, would almost certainly lead to considerable more litter.

I'm not familiar with how many public houses within the centre of Bicester have extended hours of opening, but should the cinema be granted permission to open, and sell alcohol through the night, one or two pubs might follow suit, even if only occasionally if it made commercial sense. If this were to happen then the impact in terms noise, litter etc., could easily impact even more residents.

Conclusion

I would like the following amendments made to the application>


