Executive Summary

Introduction

- 1.1 On 8 October 2009 the Licensing Authority received an application to vary the Club Premises Certificate held in respect of Hardwick Social Club, Ferriston, Banbury.
- 1.2 On 5 November 2009 the Licensing Authority received a letter of representation from J Thomas of 155 Ferriston, Hardwick Estate, Banbury; this is attached as appendix 1.

Proposals

1.3 The proposed application is described by the applicant as:

To vary the existing licence hours as follows

- Thursday until 24:00 hrs (12 midnight)
- Friday until 24:00hrs (12 midnight)
- Saturday until 24:00 hrs (12 midnight)
- 1.4 The application to vary included variation of the current certificate to include Live Music, Recorded Music and Provision of Facilities for Making Music during the following hours:
 - Thursday from 10:00hrs until 24:00 hrs (12 midnight)
 - Friday 10:00hrs until 24:00hrs (12 midnight)
 - Saturday 10:00hrs until 24:00 hrs (12 midnight)
- 1.5 The application to vary included variation of the current certificate to open the premises from 10:00hrs on each day and to remain open until 30 minutes after the cessation of licensable activities to allow for dispersal and drinking up time.

Background Information

- 2.1 The existing Club Premises Certificate came into force on 24 November 2005.
- 2.2 The certificate allows the supply of alcohol to members and guests for consumption **On** the premise and the supply of alcohol to a member in person for consumption **On** and **Off** the premise.
- 2.3 This licensable activity is permitted for the following times:

2.4 The existing Club Premises Certificate details the opening hours of the club to be:

2.5 It should also be noted that there is a Premises Licence in place for the same building. This permits the following licensable activities to be provided for members of the public:

Provision of Regulated Entertainment

- Plays
- Indoor Sporting Events
- Live Music
- Recorded Music
- Performances of Dance
- Anything of a similar description to that falling within live and recorded music

Provision of Entertainment Facilities for

- Making Music
- Dancing
- Entertainment of a similar description to that falling within making music or dancing

Provision of late night refreshment

2.6 These licensable activities are permitted for the following times:

Premises Licence details that between 09:00 and 24:00 (midnight) Monday to Sunday

up to 4 occasional extensions at the discretion of the committee to extend the terminal hour to 01.00 with prior notification to Police and Licensing Authority.

Key Issues for Consideration/Reasons for Decision and Options

- 3.1 The Licensing Act 2003 states that all licensing matters must promote the four Licensing Objectives, they are:
 - The prevention of crime and disorder;
 - Public safety;
 - The prevention of public nuisance; and
 - The protection of children from harm

- 3.2 Representations received have stated concerns in relation to potential issues in respect of the prevention of public nuisance. Paragraph 3.3 details how the applicant intends to promote the four licensing objectives in general. Paragraph 3.4 details how the applicant intends to promote the prevention of public nuisance objective
- 3.3 Hardwick Social Club operates a policy of strict observation of all licensing objectives
- 3.4 Doors Closed to minimise noise
 Regulated noise level on the Jukebox
 No Litter
 No Cooking on the premise
 Full notices on building asking patrons to respect local neighbours and leave quietly.

Hardwick Social Club, Ferriston Variation late night opening Thurs-Sats until Midnight

Reference the above Notice, I wish to object to the application by Hardwick Social Club for an extension until midnight on three consecutive nights Thursday, Friday and Saturday, for the following reasons:

- 1. The volume of noise from music events/TV and loud voices etc are not contained within the building itself.
- 2. The two side doors facing towards these properties are currently continously left to stand open for smokers, and other members to frequently leave and reenter throught opening hours.
- 3. The lighting from this side of the building, inparticular the floodlight, causes a nuisance which will be aggrevated by the extension of hours, on so many days of the week.
- 4. The extension until midnight will mean additional noises from car doors slamming, engines, and voices, with stragglers until 12.30 or later, as has been experienced in the past.
- 5. The extension of three consecutive nights will greatly interfere with residents right to the quiet enjoyment of their homes for the above and other reasons.
- 6. It is suggested that the Community Centre's application should be amended, to be for extension of Saturday nights only until midnight with the condition that the area is cleared quicky by the Management, to prevent raucus noise, damage etc that has occurred in previous years in what is a residential area.
