# Purpose of report

To consider an application for a Licensing Act 2003 Premises Licence variation for Costcutter Express, Bloxham Service Station, Bloxham

#### 1.0 Recommendations

1.1 There is no recommendation, but in considering the representations received and what is appropriate for the promotion of the licensing objectives, the steps the Sub-Committee can take are outlined in paragraph 6.2.

#### 2.0 Introduction

2.1 To consider an application for a variation to a premises licence submitted for Costcutter Express, Bloxham Service Station, Bloxham.

# 3.0 Report Details

- 3.1 Costcutter Express will be situated in Bloxham Service Station, South Newington Road, Bloxham.
- 3.2 An application for a Licensing Act 2003 premises licence variation was submitted to Cherwell District Council on 19 February 2018 to extend the hours for the sale of alcohol and to add the provision of late night refreshment. The openings hours are currently 24 hours, seven days a week however the garage is only open from 06.00 23.00 (Appendix 1) . The variation application seeks to extend the sale of alcohol from 06.00 23.00 to 24 hours and include late night refreshment from 23.00 05.00. Late night refreshment is the provision of hot food and drink (Appendix 2 and 3).
- 3.3 The premise licence was originally granted on 24 November 2005 to St Albans Operating Company and transferred on 24 July 2015 to Motor Fuel Limited. There is no adverse history recorded against this application.

#### 4.0 Conclusion and Reasons for Recommendations

4.1 There is no recommendation.

#### 5.0 Consultation

- 5.1 When an application for a premises license variation is submitted the applicant must display a blue notice at or near the relevant premises and advertise the application in a local publication no later than 10 days after submitting the application. This was published in the Banbury Guardian on Thursday 1 March 2018. The consultation period runs for 28 days from the day after the application is received. This gives interested parties and responsible authorities the opportunity to make representations in relation to the application.
- 5.2 The responses from responsible authorities were as follows:
  - Police no objection
  - Fire Service no response
  - Child Protection no response
  - Trading Standards no response
  - Health & Safety Executive no response
  - Environmental Protection no objection
  - Health Protection no objection
  - Planning no objection
  - Parish Council Representation received
- 5.3 There have also been 27 representations received from local residents all objecting to the application. One resident has supported the application. 10 representations received from local residents were invalid.
- 5.4 The applicant and all interested parties submitting representations have been invited to attend this hearing.

# 6.0 Alternative Options and Reasons for Rejection

- 6.1 At the end of the consultation period the licensing authority must hold a hearing if relevant representations are received. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
  - the prevention of crime and disorder
  - public safety
  - the prevention of public nuisance
  - the protection of children from harm
- 6.2 The steps the Sub-Committee can take are to:
  - issue the licence as applied for;
  - issue the licence with amended hours or licensable activities
  - reject the application if it is considered necessary in order to promote the licensing objectives

# Annex 1 – Mandatory

#### All Premises Licence authorising supply of alcohol

The licence is granted subject to the Mandatory conditions for sale of alcohol as set out in the Licensing Act 2003 as amended by the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 and Order 2014.

- No Supply of alcohol may be made under the Premises Licence -
- At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or a)
- b) At a time when then the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended
- Every supply of alcohol under the Premises Licence must be made, or authorised by a person who 2. holds a Personal Licence
- The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises
- In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
- games or other activities which require or encourage, or are designed to require or encourage, individuals to -
- drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- ii. drink as much alcohol as possible (whether within a time limit or otherwise);
- provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective:
- provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available
- The premises licence holder or club premises certificate holder must ensure that an age verification 5.1 policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- The designated premises supervisor in relation to the premises licences must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either:-
- a holographic mark or a.
- an ultraviolet feature b.
- 6. The responsible person must ensure that -
- where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures:-
- beer or cider: ½ pint; i.
- gin, rum, vodka or whiskey: 25ml or 35ml; and ii.
- iii. still wine in a glass: 125ml; and
- these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.


#### **Minimum Drinks Pricing**

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price
- 2. For the purposes of the condition set out in paragraph 1 -
- a. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
- b. "permitted price" is the price found by applying the formula -


#### P=D+(DxV)

#### Where: -

- i. P is the permitted price
- ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of alcohol, and
- iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of alcohol;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
- i. The holder of the premises licence
- ii. The designated premises supervisor (if any) in respect of such a licence, or
- iii. The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e. "value added tax" means value added tax charged in accordance with Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4.1 Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax
- 4.2 The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day



I notice that an application has been made to vary the premises licence at the following address:-

Costcutter Express Bloxham Service Station South Newington Road Bloxham Banbury OX15 4QF

I would like to make a formal objection to the application on the following grounds:

- 1) I believe selling alcohol 24 hours a day at a rural petrol station will incentivise motorists to drink & drive and thus put their own
- safety and the safety of others at risk.
- 2) For those living near or actually having to drive across the petrol forecourt (as I have too) to reach my house, selling alcohol 24
- hours a day, increases the fear of a likelihood of an assault/harassment when returning home late at night plus increases the risk of

burglary.

- 3) Selling alcohol 24 hours a day will increase the public safety risk, as 24 hour alcohol sales raises the likelihood of crime and as the
- pubs in Bloxham close at 11pm, some drinkers will want to carry on drinking, so will purchase more alcohol at the petrol station
- and potentially cause public nuisance through noise, litter, smashed glass and general disorderly behaviour.
- 4) With 24 hour opening comes additional noise pollution. There are lots of houses only a few feet away from this petrol station with
- lots of young children and the increased noise pollution would put these children at risk as their sleep is interrupted, remember this
- is a quiet village with no noise between 23.00 to 6.00am.
- 5) We already have lots of HGV lorries travelling through the village and stopping on the South Newington road to 'nip in' and
- purchase snacks & alcohol from the petrol station. This causes major tail backs and frustration with other motorists and is a
- major public safety concern. Granting 24 hours opening for alcohol and refreshments will only make this public safety issue even
- more acute.
- 6) I also note with interest, there are plenty of other petrol stations in Banbury which close at 11pm, why would Bloxham be different
- and need one open 24 hours a day and selling alcohol?

And finally, I note that Esso already have a 24 hour petrol station in Chipping Norton (12.9 miles from Bloxham) and they have three already in Banbury (3.5 miles from Bloxham) all selling petrol, alcohol & refreshments 24 hours a day. There are also other non Esso petrol stations in Banbury also open 24 hours a day.

I would welcome the opportunity to attend any hearing on this matter.

#### APPLICATION 18/PRM1262/LAPRE2 -BLOXHAM GARAGE

As the ward member for Bloxham, I would just like to voice the objections of some of my constituents in the village to the proposal to not only open the garage 24/7 but also to extend the alcohol licence from 11.00pm to 5.00 a.m. and also a hot food licence for the same timings.

I am not sure what the objective is here (except, of course, money-making). Bloxham is a village, albeit a large village and seemingly growing all the time. I have lived in Bloxham for 47 years and hopefully know a large proportion of the people living here and I have never heard of a need for a 24 hour license for drinks and hot food. This application is obviously aimed at HGV drivers who sometimes drive through the night – however, this garage is on the A361 and there are 24 hour garages in both Banbury (3 miles away) and Chipping Norton (10 miles away), so where is the need for this one in a particularly charming north Oxfordshire village? It will also become a target place for youngsters to hang out when other places are closed.

The garage is surrounded in residences (behind, opposite and to both sides) and I would suggest that no thought whatsoever has been given to the people living in these houses. The garage is already lit up to a ridiculous level, up to 11.00pm and if this application is granted that will mean the lighting will be on all night. This is a village, not a site in the middle of a town or a city, we do not need to light up our village with neon lights throughout the night, our smaller roads and lanes have recently been upgraded to LED lamps which do make the village a little bit darker, this would defeat that objective.

If these extra hours do attract the long distance HGV drivers, (and I cannot see who else is going to be driving round in the middle of the night), I cannot imagine what problems that will cause for the residents surrounding this garage with the constant noise of large trucks pulling in and out and if they do also buy hot food, they will not be eating it whilst driving but will pull over on the forecourt, leave their engines running to keep warm, and eat their hot food, causing even more air pollution than we already have in the village.

Yes, it is quite handy to have a garage in the village but not with these unnecessarily long opening hours and I am quite sure that the staff in the garage cannot be happy about it as obviously they will have to work shifts to cover all the hours.

Over the last few years, this garage has extended its opening hours several times and probably with little or no consultation with surrounding residents and I would ask the panel to seriously consider all the problems that may arise from this latest application for yet another extension of trading hours. I would stress again, that this is a rural village, albeit, on a main 'A' road, and residents who live here have a right to at least have a peaceful night's sleep. We do NOT need an all-night garage with hot food and alcohol also available!

#### Dear Sir / Madam

I write to you in objection of the above application. I understand that the owners of Bloxham service station, Motor Fuel Group, have applied to extend the opening hours of the service station and serve alcohol to 24 hours.

I have several objections set out below but firstly I do not believe that a license to sell alcohol in a village 24/7 adds any benefit to the community. The village of Bloxham has three successfully run pubs, the co-op and the service station that all serve us well.

Currently the service station closes at around 23:00hrs each evening and opens at 06:00hrs. However I have noted that business slows to the occasional shopper of fuel or provisions after 20:00hrs, it is also my understanding that should the service station want to stay open for longer hours to sell fuel they already have this right.

#### My objections:

- 1. I understand that as a local authority you have a duty to control the density of licensed premises especially if it could impact health or antisocial behavior. It appears that the only commercial reason for the service station staying open 24 hours is the sale of alcohol my objection is that this serves to only encourage late night drinking that can lead to health problems, antisocial behavior and an extra burden on police and ambulance services.
- 2. Over the last 10 years the service station has undergone several rebrands, each time more lights and advertising have been added to the point now that it effects local homes with the pollution of light. Should the current hours be extended I believe this would cause a Statutory Nuisance under the Environmental Protection act 1990 to many local family homes.
- 3. Noise is already an issue from the service station when cars, motorbikes, HGV's and delivery drivers leave engines running, rev the engines or accelerate away from the station, music is often played and occasional shouting and yelling. While most people can tolerate this up to 20:00hrs we believe that it will cause a Statutory Nuisance after this time.
- 4. Bloxham Service Station is not a setting suitable for 24 hour opening, it is surrounded by residential properties at close proximity and in a conservation area. Our home opposite the service station is listed and part of the historic character of the village.

- 5. I have a concern that should an alcohol license be extended in this village service station it will encourage drink drivers to make the trip in a vehicle. As it has been demonstrated that the only commercial reason for opening longer is alcohol sales.
- 6. Currently the risk of antisocial behavior is minimised as service station does not sell alcohol past the pub closing times. Should these hours be extended I feel that the likely hood of this will be increased. The possible effects of this could extend to local residents littering, noise pollution, smashed glass and general public nuisance.
- 7. I do have to question the motive for this application, as the owners are a national company who applied to Sedgemore District Council I draw the conclusion that this is something that the company simply applies to all its properties regardless of the setting, the demand or the effect that it will have on local residents or the community.
- 8. Finally, I question the safety of the staff who will be on duty. Currently the shop has no facility to serve customers outside of the store through a hatch. Leaving the staff vunerable in the early hours when several miles from a police station. Should the application suggest that the sale of alcohol be on the forecourt via a hatch we would object that this will cause further nuisance to the local homes.

I trust that my objections will considered and you will refuse the application.

Where is the need for this facility? There are already 24hr fuel stations in both Chipping Norton and Banbury, each within a reasonable distance along the A361.

Under normal circumstances there is only light traffic along the A361 after 10pm and I very much doubt that any through traffic, especially HGV's, would require fuel after 10pm.

I also understand that the application includes for the sale of alcohol until 12pm. The retail of this is bound to attract some undesirable elements to the village in the late evenings, and will undoubtedly lead to anti-social behaviour.

On hearing about the above mentioned garage's plan to stay open for 24 hours, I would like to register my objections to this proposal. In the first place it is totally unnecessary as there are already two garages, one in Chipping Norton and the other in Banbury that stay open 24 hours for the sale of petrol and other goods.

Bloxham is a village that needs to be preserved as a village and not attempted to be turned into a mini model of London. If permission is given to this application then other traders might also feel keen to stay open for 24 hrs. #### To whom it may concern

I would like to strongly object to the application 18/PRM1262/LAPRE2 relating to extending the hours for the sale of alcohol and adding the provision of late night refreshments for Motor Fuel Limited at Bloxham Service Station, South Newington Road, Bloxham, OX15 4QF on the grounds that this application does not comply with any of the following:

- the prevention of crime and disorder
- public safety
- the prevention of public nuisance
- the protection of children from harm

I have lived at my property for twenty years
the garage and its customers have had on me, and my neighbours, has increased since I first moved to Bloxham in 1997. Originally the garage was only open 08.00-21.00 and over the years the extended opening hours has stretched and stretched to the point it is now 06.00-23.00. That is without the deliveries of milk, papers etc. during the period 23.00-06.00 when it is shut.

If the garage was allowed to sell alcohol and refreshments 24hours a day it does not give any resident a feeling of "well being". There have been issues of crime over the years I have lived at my property, some serious within this period, and the chances of more occasions where my children and I do not feel safe in our own home increase. It also increases the chance and threat of local crime to the garage and also any neighbouring properties. By encouraging people to be able to purchase alcohol with their petrol it is also likely it would encourage people to drink and drive which is an extremely serious matter.

To extend the opening hours and to allow alcohol to be purchased 24hrs a day encourages people to gravitate to the service station to purchase alcohol when pubs have closed or there is no alternative place without travelling to Banbury or Chipping Norton. This will disrupt our neighbourhood. Customers to the garage are currently noisy — music blaring, doors slamming, revving of engines, talking loudly during the early or late hours of the current opening and this would only get worse with extended licencing if it was approved.

Once the garage closes, the area is a quiet place at night and we can be guaranteed at the moment that after 23.00 there are no customers to the garage to cause any disruption. The threat of drunk and disorderly behaviour, particularly from younger people, who do not necessarily want to finish their Page 33

evening out when the pubs shut at 23.00, to come to the service station to top up! People do not leave the garage quietly now let alone in the small hours of the morning when the general noise levels are much lower as people are trying to sleep. It will also encourage people to congregate and treat the area as a place to socialise and hang out. The bus shelter will become a social space with alcohol and everything else they might require on tap — and a place to sit!

Customers to the garage are also politely asked (via signage) not to park across the access track leading from the garage forecourt to several properties. On a regular basis we have to ask people to move their vehicles whilst they are busy filling their car tyres with air or hoovering out their vehicles. This does not include customers who abandon their cars to pop into the shop or delivery trucks who are restricted as to where they can stop and unload. Customers also believe that our private driveway can be used as an extension to the garage parking and also to relieve themselves in our car park area when they do not have access to a WC.

Vehicles who are also not able to access the garage because of the forecourt is too busy or they are in a vehicle that is too large, also obstruct the main A361 road when they leave their vehicles there to purchase things from the shop. By allowing the garage to be a target for more customers out of hours these issues increase and are disruptive and anti social. We also find that litter is dropped and gravitates around to our driveway from the garage on a regular basis.

We would also like to be able to leave our windows open, particularly in the summer months, however this looks unlikely with the increased general disturbance that would occur if a 24 hour licence was granted. We are all working people who live around this area and expect to be able to relax and sleep well in our own homes.

We have also noted, and are objecting on a separate planning related matter, to the increased illuminated taller signage and general forecourt lights and that have again been replaced or upgraded recently. These are now shining into every neighbouring property which threatens to be a 24hour issue. The noise and light pollution disrupts and affects us all. Public safety is also at risk currently with extensive advertising positioned onto the land at the front of the garage which is believed to be public highways land. It is not possible to easily see when pulling out from the garage onto the A361.

By allowing the increased trading hours for alcohol and late night refreshments it is not allowing us to live in a family friendly environment. Nearly all of the immediate properties have children living in them and this is not encouraging a nice environment to live in.

I am also concerned to understand that the garage have sold alcohol to children under the age of 18. I know this was raised with the staff involved and it was recommended that they check the level of ID being provided. To increase the hours alcohol may be purchased it is possible that this problem will become a bigger issue.

2) For those living near or actually having to drive across the petrol forecourt

to reach my house,

selling alcohol 24

hours a day, increases the fear of a likelihood of an assault/harassment when returning home late at night plus increases the risk of

burglary.

3) Selling alcohol 24 hours a day will increase the public safety risk, as 24 hour alcohol sales raises the likelihood of crime and as the

pubs in Bloxham close at 11pm, some drinkers will want to carry on drinking, so will purchase more alcohol at the petrol station

and potentially cause public nuisance through noise, litter, smashed glass and general disorderly behaviour.

4) With 24 hour opening comes additional noise pollution. There are lots of houses only a few feet away from this petrol station with

lots of young children and the increased noise pollution would put these children at risk as their sleep is interrupted, remember this

is a quiet village with no noise between 23.00 to 6.00am.

5) We already have lots of HGV lorries travelling through the village and stopping on the South Newington road to 'nip

purchase snacks & alcohol from the petrol station. This causes major tail backs and frustration with other motorists and is a

major public safety concern. Granting 24 hours opening for alcohol and refreshments will only make this public safety issue even

more acute.

6) I also note with interest, there are plenty of other petrol stations in Banbury which close at 11pm, why would Bloxham be different

and need one open 24 hours a day and selling alcohol?

And finally, I note that Esso already have a 24 hour petrol station in Chipping Norton (12.9 miles from Bloxham) and they have three already in Banbury (3.5 miles from Bloxham) all selling petrol, alcohol & refreshments 24 hours a day. It has come to my attention that an application has been made to alter the premises licence at the following address:-

Costcutter Express Bloxham Service Station South Newington Road Bloxham Banbury OX15 4OF

I would like to make a formal objection to the application on the following grounds:

1. As we live directly behind the petrol station, 24 hour opening will bring additional noise pollution. Two of our bedrooms face directly on to the forecourt and I fear sleep deprivation will become a big issue for my family, especially during the warm Summer months when open windows at night are the only way we get any sleep. We have young children who's sleep will be compromised and I feel that is unacceptable.

- 2. We have to drive across the forecourt to access our house, selling alcohol 24 hours a day will increase the likelihood assault/harassment when returning home late at night. I also believe that a 24 hour alcohol service will promote a drink & drive culture which will put their own safety and the safety of others at risk. It will also raise the likelihood of crime and burglary. There is increased potential to cause public nuisance through noise, smashed glass, litter and general disorderly behaviour.
- 3. Light pollution is already an issue for us. I noticed that a much larger and brighter sign has been erected. It shines directly into all the rooms at the front of our house. Has permission been sought / required for this alteration? To be forced to endure this, on top of the added noise, really is outrageous. There is very little village lighting, by choice, in this area so this new sign stands out and not in a positive way.
- 4. We already have HGV lorries travelling through the village that regularly stop directly outside the filling station, on the South Newington Road, to pop in to purchase snacks etc. This causes no end of tail backs that results in traffic gridlock and is a major public safety concern for us. Granting a 24 hour opening licence will only make this public safety issue even more acute and bring the noise pollution to a new level. Bloxham is an industrious village but is quiet between 11pm and 6am. Banbury is only 3 miles away, with it's own supply of all night petrol stations. Why would Bloxham need one open 24 hours a day and selling alcohol, considering the station sits amongst residential dwellings?

I am emailing to strongly object to the change in licensing hours for the petrol station in Bloxham.

I live in very close proximity to the garage and this will have a major impact on us.

Over the years the facility has extended it's hours and 2300hrs is plenty long enough for a residential area which has very limited traffic through the village throughout the night.

My reasons and examples for objection are as follows:-

My car park area is adjacent to the petrol station and is shared with the Veterinary Surgery. Many occasions we have had glass bottles smashed in the car park and also around by the vets doorway. This is not just a nuisance but a danger to the vets clients and our working search dogs, which are often put into and taken out of our vehicles very early in the morning so the hazards are not always seen in the dark. This will just get worse and become even more regular if open to selling food & alcohol for longer periods.

Furthermore the stations customers use my area of parking for a toilet and on numerous occasions we have had theft of our property that is kept around the rear of our house.

The noise is constant for the hours the petrol station is currently open, with screeching tyres, beeping of horns, shouting and blaring stereos at night. The only reprieve is that we know it stops come 2300hrs when the garage closes. There have been incidents of fights breaking out, on one occasion I actually put my husbands ex-police dog on the leash as I was so concerned it was going to escalate further and involve damage to my property and on another occasion I had to intervene with a man beating a woman up for which I had to go to Crown Court.

In comparison to other 24hr garages in the area, Bloxham has residential property directly in front of the forecourt, directly behind & to the side so noise nuisance & light pollution is a major factor. The fact this is trying for a 24hr alcohol license is obviously just a ploy to stay open as both Esso's in Bodicote & Ermont Way also have a 24 hour licence but no longer sell it!! I feel this whole application has been dealt with most underhandedly, with no one even being aware of it until the latter part of last week, including the Parish Council. The notice was originally placed where no one would really see it as there is normally the managers taxi parked in front of it.

I hope these are valid enough points for this application to be firmly rejected.

In order for us to enjoy our property and grounds and keep our working dogs safe and uninjured we already have to clean up daily the mess left by people visiting the garage as the broken glass can cause our dogs to be come seriously injured costing me money and remove my ability to earn money and could cost me contracts, this issue will only get worse if opening hours are extended further.

The application does not conform with Bloxham Neighbourhood Development Plan Policy BL9a.

The proposal for a 24 hour service of alcohol and hot food, with its related light pollution and noise for immediate neighbours will result in adverse harm to their environment.

The recent increase in forecourt signage, imposes an unnecessarily harsh urban intrusion into the gateway of the village.

I wish to lodge my objection to the request to extend opening hours, provide 24hr sale of alcohol and the provision of hot food sales during the night.

I am a resident of the village and live relatively close to the petrol station.

- The main objective is the noise factor that this will bring to residents living in close proximity to the site. Already since the garage extended its hours to 11pm there is the inconvenience of late delivery from petrol tankers, noisy drivers, blaring music and people loitering around consuming food & drink. Although this is not convivial to residents and village life it does generally cease at a tolerable hour.
- However the attraction of all night hot food, alcohol etc. could bring with it more unsociable issues. There is a concern once pubs etc. particularly in Banbury and out lying villages close it could increase activity. We have had a rise in criminal activity of late and concerns within the village are this could exacerbate the problem.
- Bloxham during the day is a very busy and active village with high capacity traffic flow, however, this quietens considerably into the evening. With five 24hr garages in the town the need for round the clock available petrol in Bloxham is just not necessary. As we live in Cumberford 50 metres away from this filling station we have strong reservations about them extending their licence to sell alcohol to 24 hours and hot food until 5 a.m.

There are 24 hour facilities already in Banbury and Chipping Norton and Bloxham's Co-op stays open until 10 p.m. The A361 is a very busy East / West route and traffic frequently speeds in and out of the village and the junction with Cumberford/Tadmarton Road is an accident black spot.

I write to you in objection of the above application. I understand that the owners of Bloxham service station, Motor Fuel Group, have applied to extend the opening hours of the service station and serve alcohol to 24 hours.

I have several objections set out below but firstly I do not believe that a license to sell alcohol in a village 24/7 adds any benefit to the community. The village of Bloxham has three successfully run pubs, the co-op and the service station that all serve us well.

Currently the service station closes at around 23:00hrs each evening and opens at 06:00hrs. However I have noted that business slows to the occasional shopper of fuel or provisions after 20:00hrs, it is also my understanding that should the service station want to stay open for longer hours to sell fuel they already have this right.

#### My objections:

- 1. I understand that as a local authority you have a duty to control the density of licensed premises especially if it could impact health or antisocial behavior. It appears that the only commercial reason for the service station staying open 24 hours is the sale of alcohol my objection is that this serves to only encourage late night drinking that can lead to health problems, antisocial behavior and an extra burden on police and ambulance services.
- 2. Over the last 10 years the service station has undergone several rebrands, each time more lights and advertising have been added to the point now that it effects local homes with the pollution of light. Should the current hours be extended I believe this would cause a Statutory Nuisance under the Environmental Protection act 1990 to many local family homes.
- 3. Noise is already an issue from the service station when cars, motorbikes, HGV's and delivery drivers leave engines running, rev the engines or accelerate away from the station, music is often played and occasional shouting and yelling. While most people can tolerate this up to 20:00hrs we believe that it will cause a Statutory Nuisance after this time.
- 4. Bloxham Service Station is not a setting suitable for 24 hour opening, it is surrounded by residential properties at close proximity and in a conservation area. The home opposite the service station is listed and part of the historic character of the village.

- 5. I have a concern that should an alcohol license be extended in this village service station it will encourage drink drivers to make the trip in a vehicle. As it has been demonstrated that the only commercial reason for opening longer is alcohol sales.
- 6. Currently the risk of antisocial behavior is minimised as service station does not sell alcohol past the pub closing times. Should these hours be extended I feel that the likely hood of this will be increased. The possible effects of this could extend to local residents littering, noise pollution, smashed glass and general public nuisance.
- 7. I do have to question the motive for this application, as the owners are a national company who applied to Sedgemore District Council I draw the conclusion that this is something that the company simply applies to all its properties regardless of the setting, the demand or the effect that it will have on local residents or the community.
- 8. Finally, I question the safety of the staff who will be on duty. Currently the shop has no facility to serve customers outside of the store through a hatch. Leaving the staff vulnerable in the early hours when several miles from a police station. Should the application suggest that the sale of alcohol be on the forecourt via a hatch we would object that this will cause further nuisance to the local homes.
