Result of Banbury Grimsbury and Castle By-Election

Report of Chief Executive

Purpose of report

To advise Council of the result of the Banbury Grimsbury and Castle by-election held on 1 October 2015 and to note changes to political balance and membership of Committees.

1.0 Recommendations

The meeting is recommended:

- 1.1 To note the results of the Banbury Grimsbury and Castle by-election held on 1 October 2015.
- 1.2 To note the constitution of the Council following the by-election.
- 1.3 To agree the allocation of seats on committees that are subject to the political balance requirements as set out in Table 1 following the by-election.
- 1.4 To agree the amendments to committee membership as requested by the Conservative Group and Labour Group as necessitated by the changes to the proportional allocations following the by-election as set out in Table 2 and the addendum to this report (to follow).
- 1.5 To note the amendment to the membership of the Joint Councils and Employee Engagement Committee as requested by the Conservative Group Leader set out in the addendum to the report (to follow).

2.0 Introduction

2.1 A by-election for the recently vacated seat in the Banbury Grimsbury and Castle ward of Cherwell District Council was held on 1 October 2015.

2.2 Following a district by-election the result is reported to Council for information. As a result of the by-election, adjustments to the allocation of seats and membership of Committees is required.

3.0 Report Details

- 3.1 The overall turnout for the Banbury Grimsbury and Castle by-election held on 1 October 2015 was 21.79%
- 3.2 The number of votes cast for the candidates was:

Kenneth William Ashworth (Liberal Democrats) - 73 votes

Shaida Hussain (Labour Party) - 781 votes

Christopher John Manley (The Green Party) - 72 votes

Tony Mepham (The Conservative Party Candidate) - 661 votes

Linda Michelle Wren (UK Independent Party (UKIP)) - 150 votes

- 3.3 Shaida Hussain (Labour Party) was duly elected.
- 3.4 Following the by-election, the constitution of the Council and political groups is 39 (78%) Conservatives, 9 (18%) Labour, 1 (2%) Liberal Democrats and 1 (2%) Independent.
- 3.5 Under the political balance regulations in the Local Government and Housing Act 1989, allocations are made to political groups, any member not in a political group is consequently not automatically entitled to seats on committees. Therefore in Table 1 below, all group percentage allocations have been rounded up. The figures marked by an asterisk take account of this adjustment.
- 3.6 The proportionality calculations require the Labour Group to release one seat to the Conservative Group. The Labour Group has advised that the relevant seat is on the Appeals Panel. This is indicated in the table in brackets.
- 3.7 Proposed changes to the membership of the Joint Commissioning Committee are the subject of a separate report on this agenda and will be addressed under that item.

Appeals Panel members may not serve as members or substitute members of the Personnel Committee.

Joint Commissioning Committee members may not serve as members or substitute members of the Joint Appeals Committee

- **Joint Appeals Committee** members may not serve as members or substitute members of the Joint Personnel Committee.

- 3.9 Where advised by the Leader of the Conservative Group and the Leader of the Labour Group, the names of the councillors to be removed / added are included below. Other changes will be advised via an addendum to this report when available:

NB. At the Annual Council meeting in May 2015, the Labour Group was required to give 3 seats to the Conservative Group. These were on the Appeals Panel, Licensing Committee and Planning Committee. The adjustments above take account of this as well as the revised proportional allocations.
