2.0 Introduction

2.1 Following the creation of the Apprenticeship and Training Company Apprenticeship and Training Agency (ATA) board, Cherwell District Council appointed a representative to the board.

3.0 Report Details

- 3.1 In April 2016 Executive resolved to appoint a representative to the Apprenticeship and Training Company Apprenticeship and Training Agency (ATA) board (Minute 144, Executive meeting, 4 April 2016).
- 3.2 At its meeting of 20 December 2016, the CDC Shareholder Committee noted that the ATA was to be classed as an outside body to which the council nominates representatives and has a financial relationship with as the accountable body for the

- LEP funding and therefore does not fall within the remit of the Shareholder Committee.
- 3.3 The Leader of the Council would now like to appoint a second representative to the ATA Board.
- 3.4 As the ATA is an outside body, future appointments will be made as part of the annual outside body appointment process in the summer of the municipal year to which they apply.
