Recreation and Health Fees and Charges 2017-18

Report of Leisure Facilities and Project Manager

Purpose of report

To set fees and charges for 2017-18 for Spiceball Leisure Centre (SLC), Woodgreen Leisure Centre (WGLC), North Oxfordshire Academy (NOA), Cooper School, Bicester Leisure Centre (BLC) and Kidlington and Gosford Leisure Centre (KGLC).

1.0 Recommendations

The Lead Member is recommended:

1.1 To agree the fees and charges as set out in the attached annexes.

2.0 Introduction

- 2.1 The existing Sports Centre Modernisation Contract for Spiceball Leisure (SLC), Bicester Leisure Centre (BLC) and Kidlington and Gosford Leisure Centre (KGLC) with Parkwood Leisure require an annual review of core fees and charges in line with RPIx.
- 1.2 The existing Contract for Woodgreen Leisure Centre (WGLC) with Parkwood Leisure requires an annual review of core fees and charges in line with CPI.
- 1.3 The Authority is required to contractually review and approve these increases.
- 1.4 In line with the budget process, Cooper School and NOA charges are proposed to increase in line with 2% inflation.

3.0 Report Details

- 3.1 The existing Sports Centre Modernisation Contracts (SLC,BLC and KGLC), Full Services Specification, Schedule 1, Part II, Clause 2.4 refers.
- 3.2 The existing Management Contract (WGLC), Full Services Specification, Schedule1, Part 1D, Clause 1.18 refers.
- 3.3 Woodgreen Pool Agreement with Banbury Town Council (for annual contribution £50,000) 24 April 2009 Clause7.
- 3.4 Budget 2017-18 estimated income for Cooper School and NOA.

4.0 Conclusion and Reasons for Recommendations

4.1 Agree proposed Leisure Centre, NOA and Cooper price increases in order to meet the Authority Leisure Contract requirements and meet the 2017-18 budget estimate.

6.0 Alternative Options and Reasons for Rejection

6.1 The following alternative options have been identified and rejected for the reasons as set out below.

Option 1: To not agree proposed leisure centre charges would have potential SCM Schedule 17 Benchmarking implications due to a negative impact on PW income.

Option 2: To not agree to proposed charges for NOA/Cooper would have budget 17/18 income estimate consequences.

7.0 Implications

Financial and Resource Implications

7.1 Cooper School and NOA fees and charges are in line with estimates with price increases reflected in the revenue budget for 2017-18.

It should be noted that:

The outdoor swimming pool charges at WGLC will be set in consultation (before May 2017) with BTC in accordance with the Agreement.

Key Holder Licence Agreements/Fees are currently in place with Banbury Harriers Athletics Club and Banbury Hockey Club.

SLC, KGLC and BLC are in line with the SCM contract where each December CDC requires PCL to inform us of their proposed core charges from 1 April based on RPI for the year. On this basis, the preceding 12 months Dec - Nov RPI = 2.04% this is confirmed as acceptable. WGLC are in line with Management contract where each December CDC requires PCL to inform us of their proposed core charges from 1 April based on CPI for the year. On this bases the preceding 12 months Dec – Nov CPI = 0.9% this is confirmed as acceptable
