# Purpose of report

To review the Air Quality Action Plan for Banbury, Bicester and Kidlington prior to consideration by Executive

### 1.0 Recommendations

The meeting is recommended:

1.1 To review and comment on the Air Quality Action Plan for Banbury, Bicester and Kidlington prior to consideration by Executive for approval on the 3 April 2017.

### 2.0 Introduction

- 2.1 A report on the Air Quality Action Plan (AQAP) for Banbury, Bicester and Kidlington went to Executive on the 6 March 2017 for approval. A copy of the report is attached as Appendix 1 and a copy of the AQAP is attached as Appendix 2.
- 2.2 The Executive resolved that the AQAP be deferred to enable the report to go to the Overview and Scrutiny Committee to review prior to consideration by Executive at its meeting on the 3 April 2017.

# 3.0 Report Details

- 3.1 The proposed action plan measures for consideration are shown in Tables 5.1 to 5.5 in the AQAP; Table 5.1 lists the general measures that would apply to all four Air Quality Management Areas (AQMAs) and Tables 5.2 to 5.5 the measures specific to one of the AQMAs.
- 3.2 Further consideration will also need to be given to the measures shown in Table 6.1 of the AQAP. These were considered during the consultation process but are not being taken forward because there is currently no funding or commitment to develop them. The proposal is that these measures would be reconsidered at each review of the AQAP.

#### 4.0 Conclusion and Reasons for Recommendations

4.1 The production of an AQAP is mandatory once an order to declare an AQMA has been issued. The Council has issued an order for each of the four AQMAs declared.
