The mental health work that CDC delivers is often in partnership with other organisations and other mental health initiatives that are delivered around the District are commissioned either via OCC Public Health, OCC Children's services or through the CCG. We have been a partner of the MH concordat partnership since it was formed in 2019 and have helped to shape the recently launched framework. The framework has been set out by all of the concordat's partnership organisations. The framework outlines how we will work together for everyone in Oxfordshire. This relates to homelessness legislation. The national statistics are published and this includes information on ‘The number of households owed a homelessness duty by sexual identification of lead applicant’.</p> <p>We would not be able to change the reporting requirements to include whether or not someone’s sexual identification has led to them becoming homeless, as the system is designed to provide the data required for the MHCLG national stats – 1 authority could not amend this independently”.</p> <p>The information was sent to Councillor Dallimore on 10 August.</p> | <p>Councillor Dallimore to advise if the response sufficiently answers his question, or if more information required.</p>  |
