Details

Overview and Scrutiny Draft Work Programme 2010/11

- 1.1 The overview and scrutiny work programme as at the year end 2009/10 is attached at Appendix 1.

Update to the Work Programme Items 2009/10

Scrutiny – agreed topics for consideration at committee meetings

Kidlington Pedestrianisation Capital Bid

- 2.1 In March 2010 the Committee agreed to consider this referral from Council at their June meeting.

Houses in Multiple Occupation (HMO) and Planning Policy

- 2.2 In March 2010 the Committee agreed that a group of members should meet informally with planning officers to consider the potential to use the new planning legislation to develop criteria to control the number and concentration of HMOs in the district. The results of those discussions will be presented at the June meeting.

Built Environment Conservation Area Policy

- 2.3 In March 2010 the Committee agreed that this should be included as a review topic on the work programme for 2010 -2011. The Committee will wish to determine the exact remit and preferred timing of that review (see Appendix 2 ~ draft review plan).

Monitoring – to examine responses to scrutiny reports and to check on implementation of recommendations

Democratic Engagement with Young People

- 2.4 In 2009/10 the Board scrutinised the Council's arrangements for democratic engagement with young people. The Committee's report will be submitted to the Executive in the summer of 2010.

Crime and Anti-Social Behaviour

- 2.5 In the spring of 2010 the Committee considered a Task & Finish Group report into crime and anti-social behaviour and agreed to refer it to the Executive in parallel with the report on democratic engagement as they raised complementary issues. The Task & Finish Group will be submitted in the summer of 2010.

Private Sector Housing Strategy

- 2.6 The Committee will review the progress against the Strategy Action Plan in the spring of 2011.

Preparations for the 2012 Olympics

- 2.7 The Committee agreed to review progress on preparations for the 2012 Olympics and the work of the Member/Officer working group in the summer of 2010. The Portfolio Holder for Customer and ICT (with special responsibility for tourism) has suggested that it would be better to defer the item until the autumn when there would be more to discuss.

RAF Bicester

- 2.8 The Committee agreed to maintain a "watching brief" on this item and

the Portfolio Holder and Strategic Director will circulate briefing notes as appropriate.

Residents' Parking Schemes

- 2.9 The Committee agreed to maintain a "watching brief" on this item and the Portfolio Holder and Strategic Director will circulate briefing notes as appropriate.

Work Programme Items 2010/11

Scheduling – to identify and agree potential topics for scrutiny

Proposed Scrutiny Topics

- 3.1 In addition to the confirmed items carried forward from the 2009/10 work programme, members of the Committee have suggested the following items for consideration for inclusion on the Work Programme 2010/11. The Committee will wish to consider these items and decide if they feel they are appropriate for inclusion on the Work Programme.
- Youth Services (suggestion carried forward from 2009/10)
 - Preparations for an Ageing Population (suggestion carried forward from 2009/10)
 - Review of Secondary Education Attainment Levels In Cherwell (see Appendix 3 ~ draft review plan)
- 3.2 During the year the Committee will wish also to review the Forward Plan to consider whether there are any issues which they would wish to look at in more detail in advance of the Executive discussion and decision. To facilitate a thorough consideration of the topic the Committee will need to identify the Forward Plan items at an early stage of the decision making process. The Forward Plan is updated and published monthly; an electronic copy is available on the Council's website and all councillors are sent a prompt containing the website link.
- 3.3 In considering these suggestions for the work programme and prioritising the topics the Committee will wish to consider the resources available to support the work and the timescales. The Committee should also reflect on the demands that scrutiny reviews place on the resources in the individual service areas.
- 3.4 The Committee will also wish to consider the priority checklist. The current, informal criteria applied to all suggestions for a scrutiny review are that it must:
- be of concern to a group of people living within the Cherwell District;
 - relate to a service, event or issue in which the Council has a significant stake or over which the Council has an influence;

- not be an issue which scrutiny has considered during the last 12 months;
- not relate to an individual service complaint;
- not relate to an individual planning or licensing application.
