### **1 Overview and Scrutiny Work Programme 2010/11**

- 1.1 Appendix 1 sets out the existing work programme for both the Overview and Scrutiny Committee and the Resources and Performance Scrutiny Board, as agreed at the committee meetings in June 2010.

### **2 Preparations for an Ageing Population**

- 2.1 At the last meeting the Committee agreed to consider whether to undertake a scrutiny review into "Preparations for an Ageing Population".
- 2.2 This issue was the subject of a lengthy and in-depth scrutiny review commissioned by the Oxfordshire Joint Health Overview & Scrutiny Committee together with the Oxfordshire County Council Social and Community Services Scrutiny Committee in December 2006. Appendix 2 contains an extract of the minutes of the Oxfordshire Joint Health Overview & Scrutiny Committee which considered the report on 20 November 2008. Appendix 3 contains an edited version of the scrutiny report. If Committee members would like a copy of the full 78 page report please contact the Scrutiny Officer.

### **4 Kidlington Pedestrianisation Capital Bid**

- 4.1 On 12 July 2010 the Executive will consider the Committee's recommendation that the Portfolio Holder for Resources and Communication be recommended to make available a supplementary estimate for the Kidlington Pedestrianisation capital bid (value £25,000) in order to bring the village in to line with the other urban centres of the district.
- 4.2 The Scrutiny Officer will brief the Committee on the outcome of the Executive discussion at the meeting.

## **5 Centre for Public Scrutiny Annual Conference and RAF Bicester**

### **Centre for Public Scrutiny Annual Conference**

- 5.1 Councillor Donaldson will brief the Committee on his attendance at the Centre for Public Scrutiny Conference on 30 June – 1 July 2010.

### **RAF Bicester**

- 5.2 The Council remains concerned about the condition of the buildings and structures on the Technical Site at RAF Bicester and has been lobbying at the highest level, including meeting with the, then, Minister, to negotiate a programme of repair. The Council was advised the MOD had minimal budget for this work. Defence land exemptions from planning control prevent the Council taking meaningful enforcement action against the MOD. Recent meetings with the MOD have indicated that progress towards site disposal will be slow due to legal procedures around the rights of the owners of the land before it became a military base.
- 5.3 The Domestic Site was disposed of separately and has recently been purchased by City and Country Group. We have written to the company inviting them to discuss their ideas for the future of the site. The owners are still considering their plans and have not yet responded.
- 5.4 The Council published planning guidance on the future of the whole of RAF Bicester last December, working with English Heritage and Defence Estates, and this document will be used to determine planning applications for the reuse of this redundant military site.

## **6 Overview and Scrutiny Committee Meeting 21 September 2010**

### **Secondary School Education Attainment Levels**

- 6.1 This will be an opportunity for the Committee to review secondary school education attainment levels within the district. The Committee will also consider the report of the Oxfordshire County Council scrutiny review into this subject. It is hoped that the County Council Cabinet Member and lead officer will be able to attend the meeting.
- 6.2 Members of the Committee will then be in a position to consider whether there are any issues which they would wish to investigate further.

### **Built Environment Conservation Policy**

- 6.3 The Scrutiny Officer and officers from Planning will present a detailed project plan for this review which is expected to be the main item of business at the Committee's meetings in October, December and January. An initial briefing pack will also be available for that meeting.
