Draft Cherwell Local Plan 2040 (Regulation 18) Consultation

Purpose of report

The purpose of this report is to provide an overview of the emerging draft Cherwell Local Plan 2040 for the Overview and Scrutiny Committee to consider ahead of the emerging plan being considered by Executive on 5 December 2022.

1.0 Recommendations

The meeting is invited:

- 1.1 To consider exempt Appendix 1 to this report (to follow) and provide any comments to officers, in confidence, who will consider those comments in finalising the draft Plan and in advising the Executive.

2.0 Introduction

- 2.1 The Council is reviewing its Local Plan. The current Local Plan comprises the Cherwell Local Plan 2011-2031 (adopted in 2015), the Cherwell Local Plan Partial Review - Oxford's Unmet Housing Needs (2020), together with the remaining 'saved' policies from the 1996 Local Plan.
- 2.2 A new district wide Local Plan is being prepared to meet development needs for employment, housing, leisure, community facilities and infrastructure and to provide a strategy for sustainable development. The Local Plan review provides the opportunity to develop newer planning policies for:
 - i. responding to climate change and the Council's climate emergency declaration;
 - ii. placing healthy placing shaping at the centre of the Plan;
 - iii. achieving net increases in biodiversity;
 - iv. the future of our urban centres and rural areas;
 - v. responding to new Government policy and guidance including on design.

2.3 Community involvement consultations were undertaken in 2020 and 2021. A draft Plan is now emerging with the objective of public consultation commencing in December 2022.

3.0 Report Details

3.1 The draft Plan is being finalised but is not yet complete. There is a need to engage with the Overview and Scrutiny to provide an opportunity to 'check and challenge' the direction of travel and to ensure that its views are taken into account when the Plan is presented to the Executive (scheduled for 5 December 2022).

3.2 A confidential report and working draft of the Plan is appended to this covering report (to follow). Officers will briefly introduce the Plan at the meeting and invite questions.

4.0 Conclusion and Reasons for Recommendations

4.1 Officers would welcome the views of the Committee in finalising a draft Local Plan for presentation to the Executive.

5.0 Consultation

5.1 The Portfolio Holder for Planning and Development has been briefed.

6.0 Alternative Options and Reasons for Rejection

6.1 The Committee could decline to enter into private session if it so wished. However, it would not be possible to discuss the emerging Plan in public.
