85 **Communications**

Welcome

The Chairman welcomed all newly elected and re-elected Members and advised Council that this was a special meeting called due to the need for a decision relating to the Build! Programme before 31 May 2014 and this was the only item of business on the agenda. All matters relating to the appointment of Chairman, Vice-Chairman and Committees will be dealt with at the scheduled Annual Council meeting on Monday 16 June 2014.

Post

The Chairman reminded Members to collect any post from pigeon holes.

86 Build! Housing Development Programme

The Head of Regeneration and Housing submitted a report which sought support and approval to the delivery of the Build! Programme as set out in the report (annex to the minutes as set out in the minute book) at an additional capital cost to the Council of £9.5m.

The report informed Council that the Build! Programme must be completed to the relevant qualifying standard for each property subject to grant by no later than 31 March 2015 to ensure the allocated Homes and Communities Agency (HCA) grant was paid. The grant element under particular scrutiny was

identified in the exempt appendix 2 within the summary Build! Programme chart under the affordable Housing Programme.

The report further informed Council that one element of grant relating to specialist housing totalling £880K could be claimed up to 31 March 2016. This grant funding came from a different HCA grant source given the specialist nature of the housing to be provided.

Members were supportive of the proposals, acknowledging the numerous benefits accruing from the redevelopment and regeneration of the various sites identified. The successful delivery of the programme would establish the Council as leaders in this innovative field, and demonstrate a track record which would benefit the Council when bidding for future grant monies from the Homes and Communities Agency.

Resolved:

- (1) That the financial due diligence report at exempt Appendix 1 (exempt annex to the minutes as set out in the minute book) be noted.
- (2) That the full delivery of the Build! Programme as identified under the Build! Housing Summary Chart in exempt Appendix 2 (exempt annex to the minutes as set out in the minute book) be supported.
- (3) That the necessary capital resources of £9.5m, to be funded from the Council's own capital reserves to enable the delivery of the schemes identified be approved
- (4) That officers be requested to submit a further report to the Council at the completion of the development programme to further identify and conclude the financial position.

(The motion was passed unanimously).

87 Exclusion of the Public and Press

Resolved
