#### 13 Welcome

The Chairman welcomed Members and Officers to the reconvened Annual Council meeting.

The Chairman advised that the business on the agenda must be concluded and requested that all Members address the meeting through the Chair and be respectful and courteous to all meeting attendees,.

#### 14 Declarations of Interest

There were no declarations of interest.

#### 15 Annual Council Business Report 2023/2024

The Chief Executive submitted a report for Council to note the results of the 4 May 2023 district elections and agree the governance arrangements for the council following the elections for the municipal year 2023/2024.

The Chairman explained that Council had agreed recommendations 1.1 and 1.2 at the 17 May 2023 meeting prior to the adjournment.

With regards recommendation 1.3, appointment of Leader, the Chairman clarified that the process for voting on appointments, as set out in Part 4.26 of

the Constitution, was interpreted as applying to the Leader. As Chairman, his ruling on the process was that he would call for all nominations for election as Leader and would require a seconder for each.

If there two nominations (with seconders), the person commanding the highest number of votes would be elected.

If there were more than two nominations then the procedure for outside body appointments would be applied for the election of the Leader. *i.e.* "where there are more than two persons nominated for any position to be filled by the Council and of the votes given there is not an overall majority in favour of one person, the name of the person having the least number of votes shall be struck off the list and a fresh vote taken and so on until a majority of votes given in favour of one person"

If there was only one nomination (with a seconder), the nominated person would be elected.

The Chairman explained, for clarity, he would seek votes in favour of each of the nominations. If voting by a show of hands, there would be no vote "against".

The same process would be adopted if there was a recorded vote except that anyone deciding not to vote for either or any candidate would be asked to state that they abstain.

The Chairman invited the Monitoring Officer to address Council.

The Monitoring Officer explained that at meeting on Wednesday 17 May he had set out the procedure for electing the Leader, which was based on his interpretation of the Council's Constitution. Council had been left at an impasse at that meeting and he had sought external legal advice as to the interpretation of the Council's procedure rules. That advice related to Rule 4.26 of the Constitution, which included additional and unusual wording as it appears to restrict this procedure to the appointment of representatives, nominees or delegates of the Council only, yet the law requires the Leader to also be elected.

The Monitoring Officer's reading of the Constitution was not an unreasonable interpretation to have made in the circumstances of the meeting, however, there was a different interpretation that more closely aligns with the law, local government practice and this council's constitutional practices when appointing Chairs of Committees and other appointments. The Monitoring Officer explained that on this basis, he was interpreting the Constitution as the Chairman had just ruled.

The Monitoring Officer explained that it was his job to interpret the Constitution and, with the benefit of external advice, he believed the process being adopted at the meeting was sound. The Monitoring Officer confirmed he was not changing the Constitution, but was interpreting it having regard to

legislation and other Cherwell District Council practices for Member appointments.

The Monitoring Officer confirmed that the change of process did not favour any political group, it did however result in certainty over the appointment of a Leader to give effect to a legal framework adopted by the Council to enable an administration to run the council's business on behalf of its residents.

The Monitoring Officer confirmed that to move forward, the process set out by the Chairman would be used for electing the Leader and the Chairman's ruling should be complied with.

The Chairman advised that he had received two nominations for Leader, Councillor Wood, seconded by Councillor Nell, and Councillor Woodcock, seconded by Councillor Cherry.

There were no further nominations. There being two nominations, the Chairman confirmed that the candidate commanding the highest number of votes would be elected Leader.

The Monitoring Officer conducted the vote. There were 21 votes for Councillor Wood, 11 votes for Councillor Woodcock and 10 abstentions.

The Chairman declared Councillor Wood duly elected Leader of the Council.

The Chairman invited the Leader report on his Deputy Leader and Executive for 2023/24. The Leader advised Councillor Nell was his Deputy Leader and Portfolios allocated as follows:

- Councillor Barry Wood Leader and Portfolio Holder for Policy and Strategy
- Councillor Adam Nell Deputy Leader and Portfolio Holder for Finance
- Councillor Phil Chapman Portfolio Holder for Healthy and Safe Communities

## **Purpose of report**

To change the Cherwell District Council representative on the Oxfordshire Joint Health Overview and Scrutiny Committee (HOSC).

#### 1.0 Recommendations

The meeting is recommended:

1.1 To appoint Councillor Lesley McClean as the Cherwell District Council representative on the Joint Oxfordshire Health Overview and Scrutiny Committee.

## 2.0 Introduction

- 2.1 The Oxfordshire Joint Health Overview and Scrutiny Committee (HOSC) is the Committee through which Oxfordshire County Council discharges its responsibility to review and scrutinise any matter relating to the planning, provision and operation of the health services in its area.
- 2.2 The membership of HOSC includes 1 member from each district/city Council in Oxfordshire.
- 2.3 The appointment of a representative to HOSC is made by Council. This report is submitted for Council to agree to change the Cherwell District Council representative to HOSC.

# 3.0 Report Details

3.1 At the 23 May 2023 reconvened Annual Council Meeting, Councillor Lynn Pratt was appointed as the Cherwell District Council representative on the Joint Oxfordshire Health Overview and Scrutiny Committee. After the Full council meeting, the Leader of the council decided that as a Scrutiny function it would be more appropriate if the

Cherwell District Council representative was from the opposition party. The Cherwell District Council rep was thus offered to and subsequently agreed to by the Leader of the opposition.

3.2 The Leader of the Progressive Oxfordshire Group, Councillor David Hingley, has nominated Councillor Lesley McLean to be the council's representative on HOSC. Councillor McLean has confirmed she would be happy to accept the appointment.

### 4.0 Conclusion and Reasons for Recommendations

4.1 Council appoints a representative to the Joint Oxfordshire Health Overview and Scrutiny Committee (HOSC). This report seeks agreement to change the council's representative to HOSC to be a member of the Progressive Oxfordshire group, in accordance with discussions between the Leader of the Council, the Leader of the Progressive Oxfordshire Group and the Chief Executive.

Topic: Rail Crossing at Sandy Lane, Yarnton

#### Motion

"Cherwell District Council has acknowledged the Climate Change Emergency.

A major contributor to excessive CO2 output are unnecessary car journeys. The proposal by Network Rail to shut the vital link between Yarnton and Kidlington by closing the rail crossing at Sandy Lane will result in a significant increase in carbon emissions.

Permanent closure would see drivers forced to use Frieze Way or Langford Lane resulting in an average extra distance travelled of nearly two miles per journey.

Based on current trends this is estimated to result in an extra 4750 miles travelled on weekdays and an additional 3800 at weekends, resulting in 1.5 million unnecessary miles per year.

The cost of such surplus miles in money is hundreds of thousands of pounds to residents and businesses who rely on their cars; and extra pollution in the form of many tonnes of carbon emissions, contrary to the Council's environmental objectives.

This would go directly against the council's ambition to reduce CO2 output generated by transport and very significantly degrade the network of contacts that currently underpins the ancient and vital community nexus around the parishes of Yarnton, Begbroke, Kidlington and Gosford and Water Eaton.

The Council therefore asks the Executive to give careful consideration to keeping this vital link open, especially knowing that Oxford University Developments are proposing to fund and build a new road bridge on their site as part of their overall vision."

"Cherwell District Council continues to excel in it's delivery of award winning active lifestyle programs including Move Together, You Move and Fast which are recognised nationally as class leading initiatives. We are all aware of the benefits, both mentally and physically that these projects have provided to numerous residents in Cherwell especially in our most deprived areas. The Council congratulates all team members for their ongoing commitment to deliver such positive impacts to our communities.

Featured below are just some of the positive impacts of the Move Together Program -

- 1500 people with Long Term Conditions on programme
- Cherwell have 37% of referrals across all the districts
- 85% reported that their mobility improved
- 72% reported that their ability to self-care improved
- 64% reported that their pain levels improved or stayed the same
- 69% reported that their levels of anxiety or depression improved

Topic: NHS Anniversary

"The 75<sup>th</sup> anniversary of the founding of the NHS has recently been celebrated, recognising the outstanding achievement represented by the setting up of a ground-breaking health and welfare system shortly after World War II.

Since then the service has gone through numerous changes and has risen to increasing challenges, not least a global pandemic where all members of the service went above and beyond the call of duty in the face of unprecedented threats to their own lives and those of their patients.

On its 75<sup>th</sup> birthday the NHS continues to struggle to cope amidst staff shortages, funding crises, crumbling infrastructure and a growing elderly population. Topic: Littering

#### Motion

"Littering in Cherwell is reaching epidemic proportions, particularly in rural areas, where hedgerows, verges and drainage ditches are becoming clogged with food wrappers, drinks bottles and other detritus, often discarded by passing motorists. Another perennial problem is that of dog mess bags left hanging on trees or simply dropped on the floor which adds plastic waste to the problem of dog fouling in recreational areas.

CDC already encourages local litter-picks and our recycling and waste team do a fantastic job of dealing with major issues like fly-tipping and general household waste. But what is also needed is a concerted campaign to highlight the nuisance of general littering and make it socially unacceptable to simply drop rubbish in towns and villages or on our roads and highways. These places should not be being treated as dustbins, impacting the environment and increasing the demand on our recycling teams to clear up the mess.

We therefore request that officers investigate the possibility of a 'Keep Cherwell Tidy' campaign to bolster initiatives already in place and to ideally report to the executive within 6 months.

Things to consider could include a focussed advertising strategy, increased provision of litter bins and dog mess bins, partnerships with food and beverage retailers to tackle the problem of discarded food and takeaway wrappers and enhanced enforcement measures for littering. We should also work with schools and colleges to foster local and civic pride in our towns, villages and green spaces amongst our young people."
