Local Plan Review – Village Services Questionnaire

Climate Emergency Survey – Interviewees Required

Cherwell District Council has commissioned 6 degrees Student Consultancy to conduct a piece of work looking at the attitudes, ambitions and challenges of parish councils around the climate emergency.

We are keen to interview parish councillors to understand these topics in greater detail from a parish perspective. Your views will help shape a report from the student consultants which will also include a number of case studies on different actions parish councils and similar organisations have taken.

Covid-19 – Local Infection Rates and Shielding List Expansion

In Cherwell there were 124 new cases in the seven days up to 12 February, a 44 per cent decrease from 223 the previous week. This is equivalent to a weekly rate of 82.4 per 100,000 residents. This is the first time the weekly rate has dropped below 100 since early December. You can access a [COVID-19 dashboard](#) on the county council's website for daily COVID-19 statistics.

Last week the government announced a national expansion of the number of individuals being asked to shield because they are considered Clinically Extremely Vulnerable (CEV) to COVID-19. This follows the development of a new model at Oxford University which looks in detail at the medical and demographic factors of those previously most affected by the pandemic. These individuals will now be prioritised for vaccination alongside those already considered CEV and will be eligible for statutory sick pay and prioritisation for online shopping slots.

Elections 2021 – Call for Support

Preparations are well underway for the elections that will take place in Cherwell on 6 May 2021. Ensuring the whole process is safe for our staff, electors and candidates is at the forefront of our planning.

Progress on Cherwell Local Plan Review

As you may have heard at the Parish Briefings earlier in the summer, the second stage of consultation on the Cherwell Local Plan Review is the 'Options Paper'. The Options Paper is currently scheduled to go to Executive for approval on the 6th September, the agenda being made public a week before the meeting.

Subject to member approval, the Planning Policy Team will be in touch in the next couple of weeks regarding arrangements for consultation, including briefings for town and parish councils. It is hoped that one of these will take place before the start of formal consultation.

Development Briefs – Sites near Yarnton and Kidlington

A focused consultation is currently underway seeking views on two development briefs for two sites in the south of the district.

The two sites are known as Land West of Yarnton and Land at Stratfield Farm, Kidlington. Development Briefs are documents that set design principles and guidelines for new development and include illustrative layouts. The development briefs will be used to inform future applications on these sites and will be used by the council as an important reference when it considers those applications.

The two sites are allocated for development in the Partial Review of the Local Plan. The start of consultation had been delayed to allow for the decision to be issued by the courts that had been made in respect to the Partial Review. This was issued on the 30 July 2021.

There are 4 further briefs in the south of the district that will be consulted on over the autumn and winter.

The consultation runs between the 11 August and 22 September 2021 covering a period of 6 weeks. Further details about the consultation and copies of the briefs are available via <https://www.cherwell.gov.uk/planningpolicyconsultation>

Oxfordshire Plan 2050 Consultation

Comments are being sought on a consultation document containing policy options for the Oxfordshire Plan 2050.

The consultation is grouped under five themes: addressing climate change; improving environmental quality; creating strong and healthy communities; planning for sustainable travel and connectivity; and creating jobs and providing homes. The document is also seeking views on spatial strategy options- how much development is needed countywide and how should it be distributed?

The Oxfordshire Plan team are holding a series of webinars (starting on 25 August) to present the consultation paper and provide the opportunity for questions. The consultation period extends to Friday 8th October and further details can be accessed on <https://www.oxfordshireopenthought.org/>

Oxfordshire Infrastructure Strategy (OxIS) Consultation

The last day of the six week Oxfordshire Infrastructure Strategy (OxIS) consultation will be Tuesday 31 August.

OxIS provides a framework for Oxfordshire County Council, Oxfordshire's five planning authorities and key partners to establish strategic infrastructure investment priorities as well as potential opportunities for funding and delivery.

There are five themes - environment, health, place-shaping, productivity and connectivity

There are clear links to the Oxfordshire Plan 2050, with OxIS setting out how to prioritise and deliver against the important infrastructure strand of the Oxfordshire Plan. Partners and the public are encouraged to take part in both consultations.
