3. Background

- 3.1 Banbury Express Food and Wine is a small convenience store on the Warwick Road in Banbury. The store currently benefits from Two premises licences issued in accordance with the Licensing Act 2003 ("the Act"). Currently the site is licensed under PRM0813 and PRM0712. Both licences permit the off sale of alcohol by retail.
- 3.2 A premises licence is granted once the applicant has satisfied the licensing authority that their proposed business will meet all of the licensing objectives, as prescribed in the Act.
- 3.3 For the promotion of the licensing objectives, mandatory conditions are attached on all premises licences, and premises' may also propose conditions to their licence which demonstrate their ability for their business to meet the requirements under the Act.
- 3.4 A copy of the Licence PRM0813, listing the licensing conditions, is attached to this report as appendix 1.
- 3.5 Any sale of alcohol must be authorised by a person who holds a personal licence issued under the Act, and every premises selling in these circumstances must have a designated premises supervisor (DPS) in place. This is a person holding a personal licence who is ultimately responsible for all alcohol sales.
- 3.6 The premises licence PRM0813 was first granted on 29 March 2021. The license was granted to Amerjit Singh acting as both the licensee and the DPS.

4. Details

- 4.1 On 8 July 2024 the Licensing Authority received an application to transfer the license from Amerjit Singh to Mr Singh & Kaur Ltd, company registration number 12890806. As part of this application the licensee also applied to change the DPS from Amerjit Singh to Surinder Singh Malhotra. A new license was issued on 19 August 2024 listing the DPS change to Mr Malhotra. The license transfer to Mr Singh & Kaur Ltd was completed and issued on 12 September 2024, Appendix 2.
- 4.2 On 19 August 2024 Cherwell District Council Licensing Department received an application from OTS requesting a review of the Licence. The grounds for the review were based on the Licensing objectives in relation to Crime and Disorder and Protection of children from harm.
- 4.3 A copy of the licence review application submitted by OTS is attached to this report as **Appendix 3**; the details of which will be presented to the committee by the review applicant.

5. Alternative Options and Reasons for Rejection

5.1 The steps the Sub-Committee can take are set out at paragraph 6.2.

6 Conclusion and Reasons for Recommendations

- 6.1 There is no recommendation. At the end of the consultation period the licensing authority must hold a hearing. It must take such steps as it considers appropriate for the promotion of the licensing objectives, which are:
 - the prevention of crime and disorder
 - public safety
 - the prevention of public nuisance
 - the protection of children from harm
- 6.2 The steps the Sub-Committee can take are to:
 - take no action;
 - modify the conditions of the Licence;
 - remove the designated premises supervisor;
 - exclude a licensable activity from the Licence;
 - suspend the licence for a period not exceeding 3 months;
 - revoke the licence.
