## Purpose of report

## 2. Executive Summary

- 2.1 This report seeks the Committee's consideration of the Proposed Cherwell Local Plan 2042 presented at Appendix 2. Should it be approved by the Executive it would be published for the purpose of inviting representations under Regulations 19 and 20 of The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) the Proposed or Pre-Submission stage of plan-making.
- 2.2 To assist the Committee, a Statement of Consultation is also presented (Appendix 3) which summarises the comments received in response to a previous Consultation Draft of the Plan (under Regulation 18) and explains how the issues raised have been taken into account. The Committee is also provided with a Local Housing Need Assessment (Appendix 4), and a position statement on emerging technical documents (Appendix 5).
